

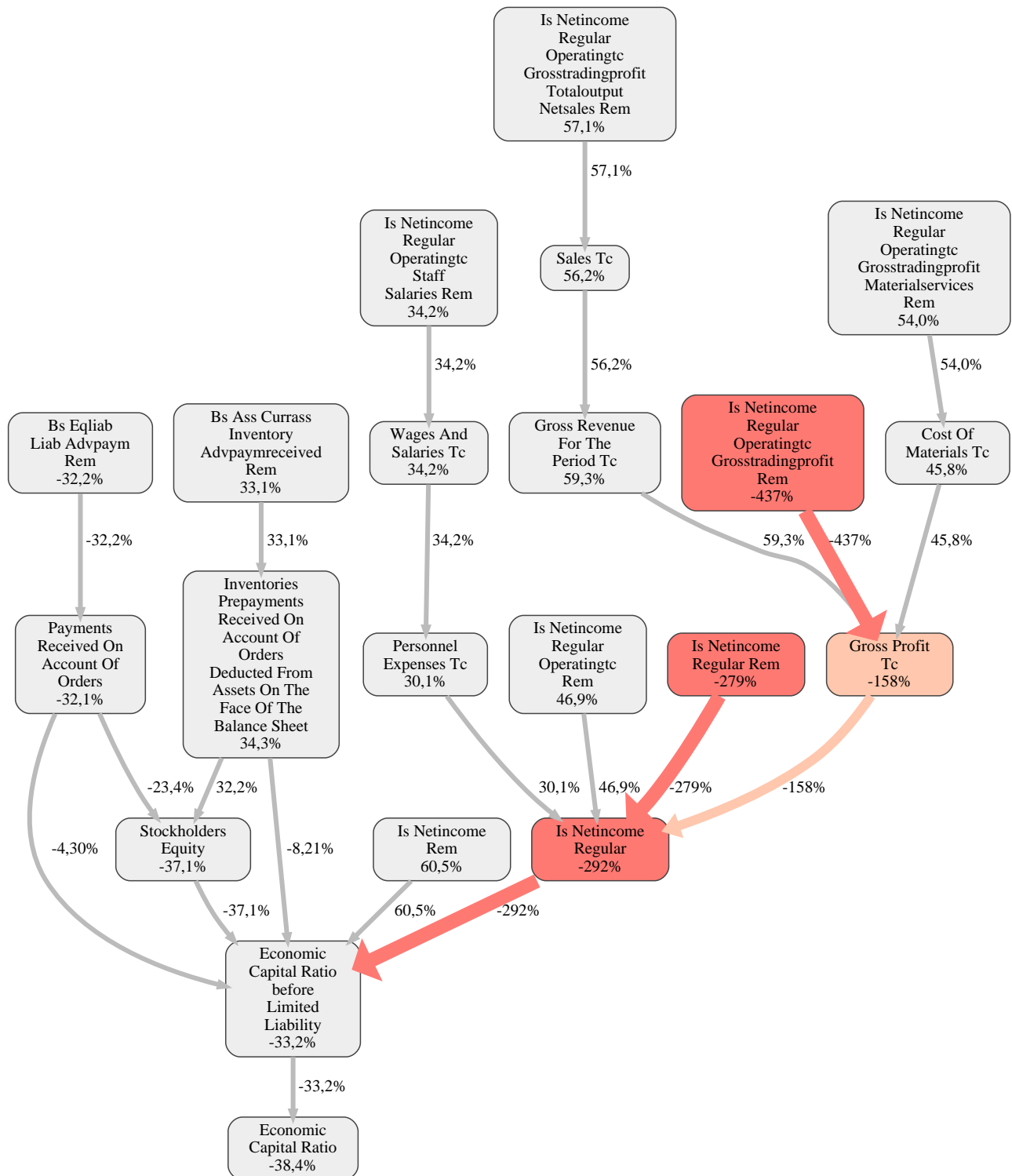

The greatest strength of Lambert Schlun GmbH Co KG compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 60% points. The greatest weakness of Lambert Schlun GmbH Co KG is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, reducing the Economic Capital Ratio by 437% points.

The company's Economic Capital Ratio, given in the ranking table, is 60%, being 38% points below the market average of 99%.
