

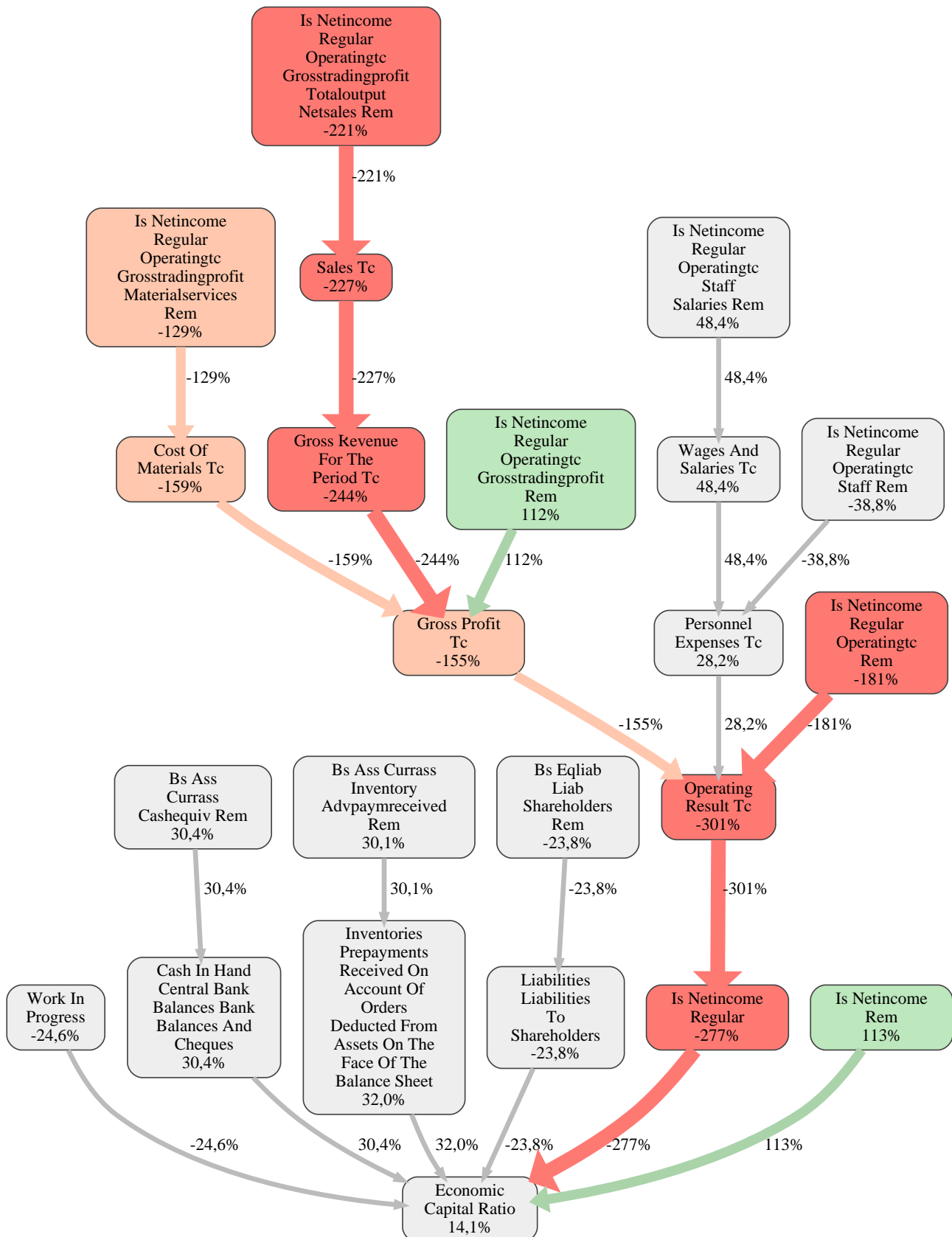

The relative strengths and weaknesses of B O Bau und Gebäudetechnik GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of B O Bau und Gebäudetechnik GmbH Co KG compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 113% points. The greatest weakness of B O Bau und Gebäudetechnik GmbH Co KG is the variable Operating Result Tc, reducing the Economic Capital Ratio by 301% points.

The company's Economic Capital Ratio, given in the ranking table, is 113%, being 14% points above the market average of 99%.
