

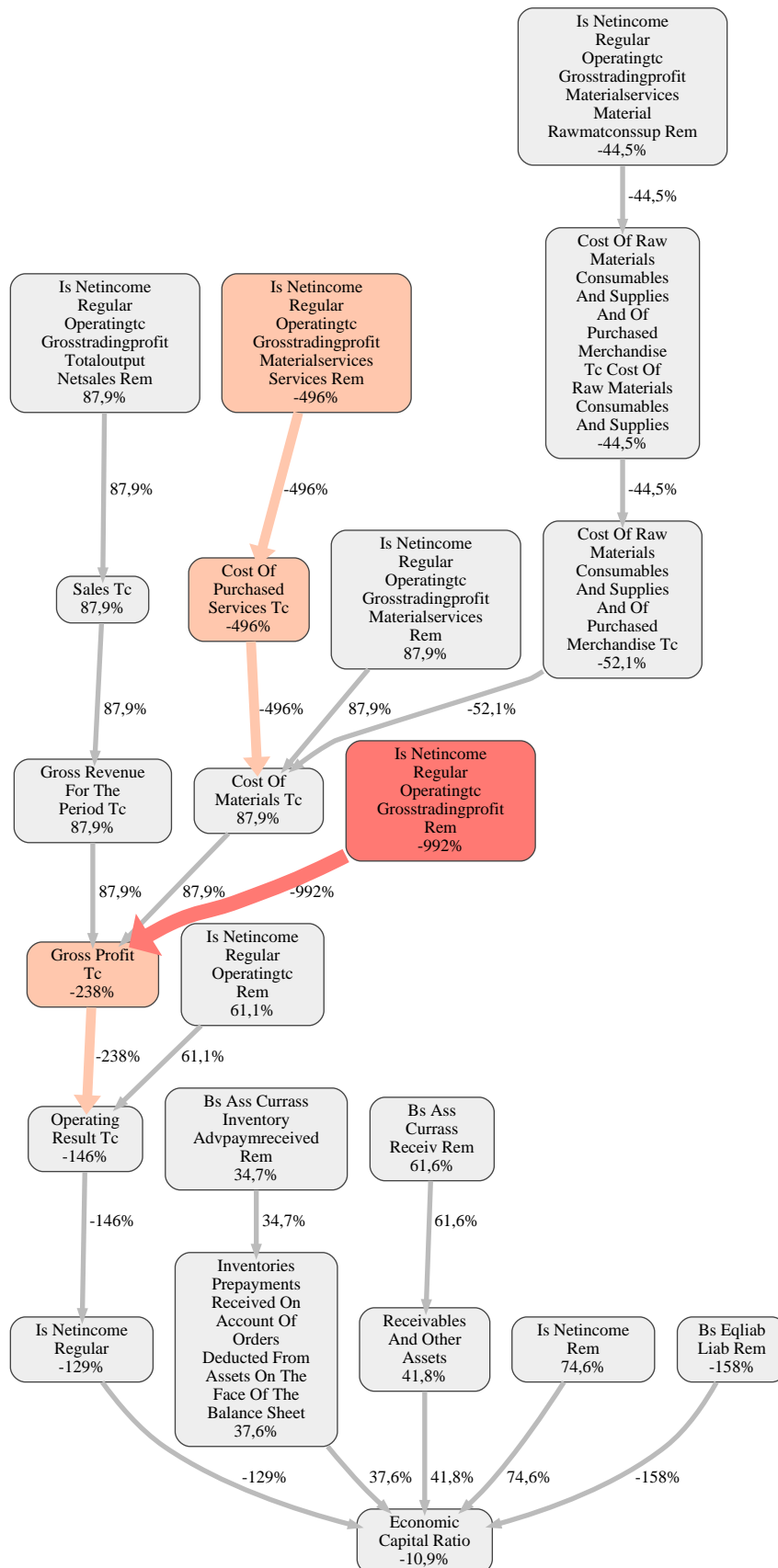

The relative strengths and weaknesses of E L I A Bau Projektmanagement GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of E L I A Bau Projektmanagement GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 88% points. The greatest weakness of E L I A Bau Projektmanagement GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, reducing the Economic Capital Ratio by 992% points.

The company's Economic Capital Ratio, given in the ranking table, is 88%, being 11% points below the market average of 99%.
