

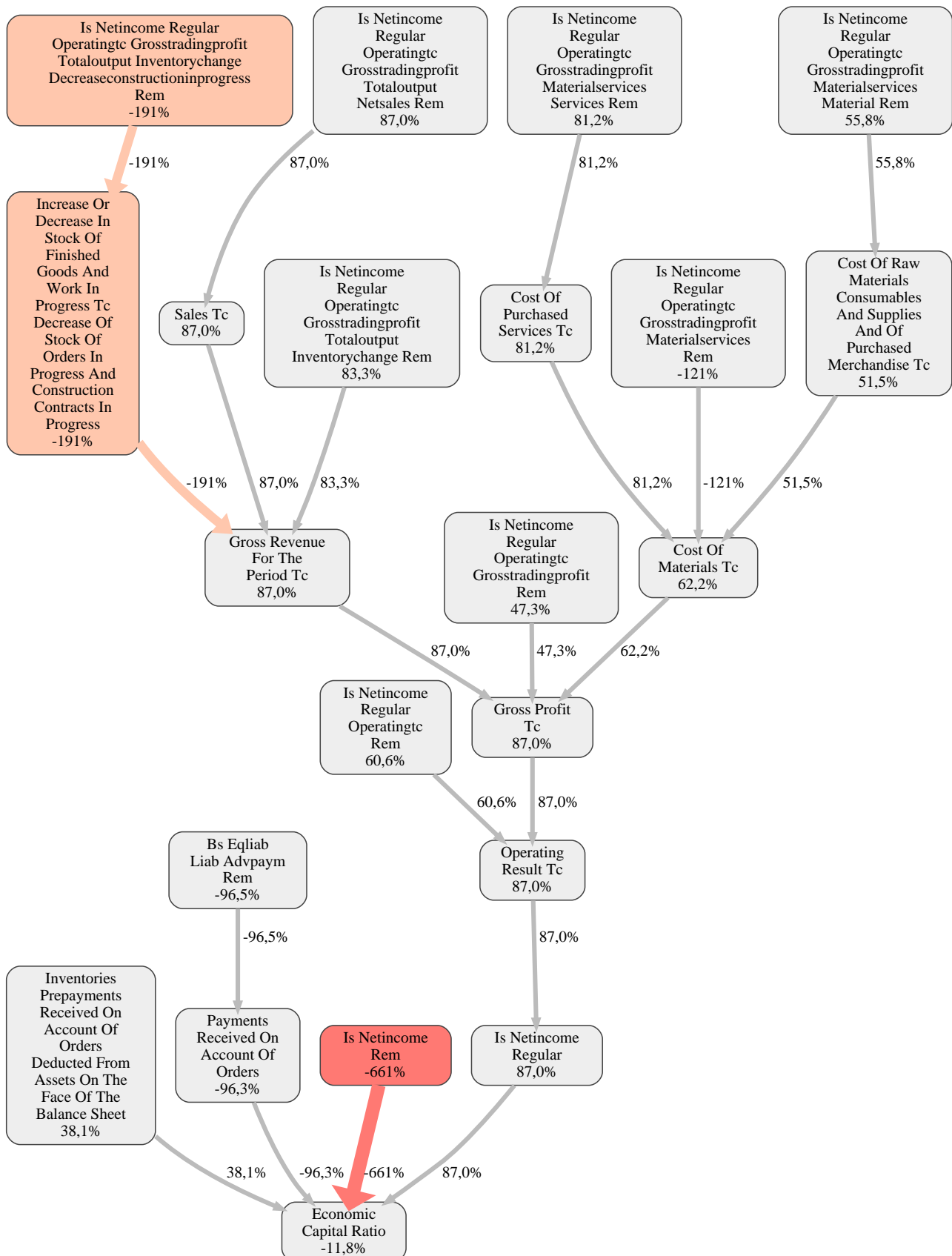

The relative strengths and weaknesses of Krüger Bau Bernau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Krüger Bau Bernau GmbH compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 87% points. The greatest weakness of Krüger Bau Bernau GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 661% points.

The company's Economic Capital Ratio, given in the ranking table, is 87%, being 12% points below the market average of 99%.
