

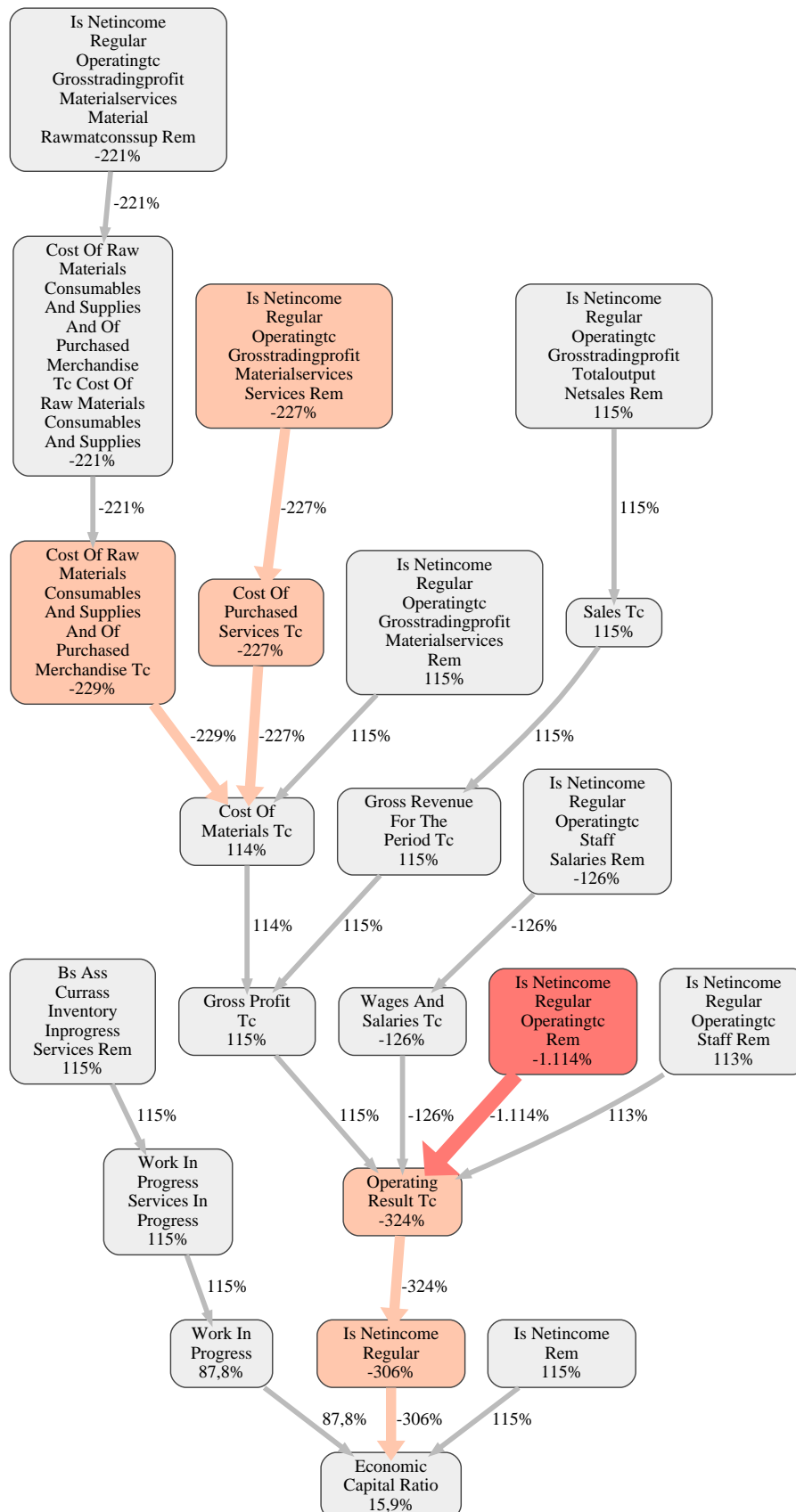

The greatest strength of Hans Holzner Baugesellschaft mbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 115% points. The greatest weakness of Hans Holzner Baugesellschaft mbH is the variable Is Netincome Regular Operatingtc Rem, reducing the Economic Capital Ratio by 1.114% points.

The company's Economic Capital Ratio, given in the ranking table, is 115%, being 16% points above the market average of 99%.
