

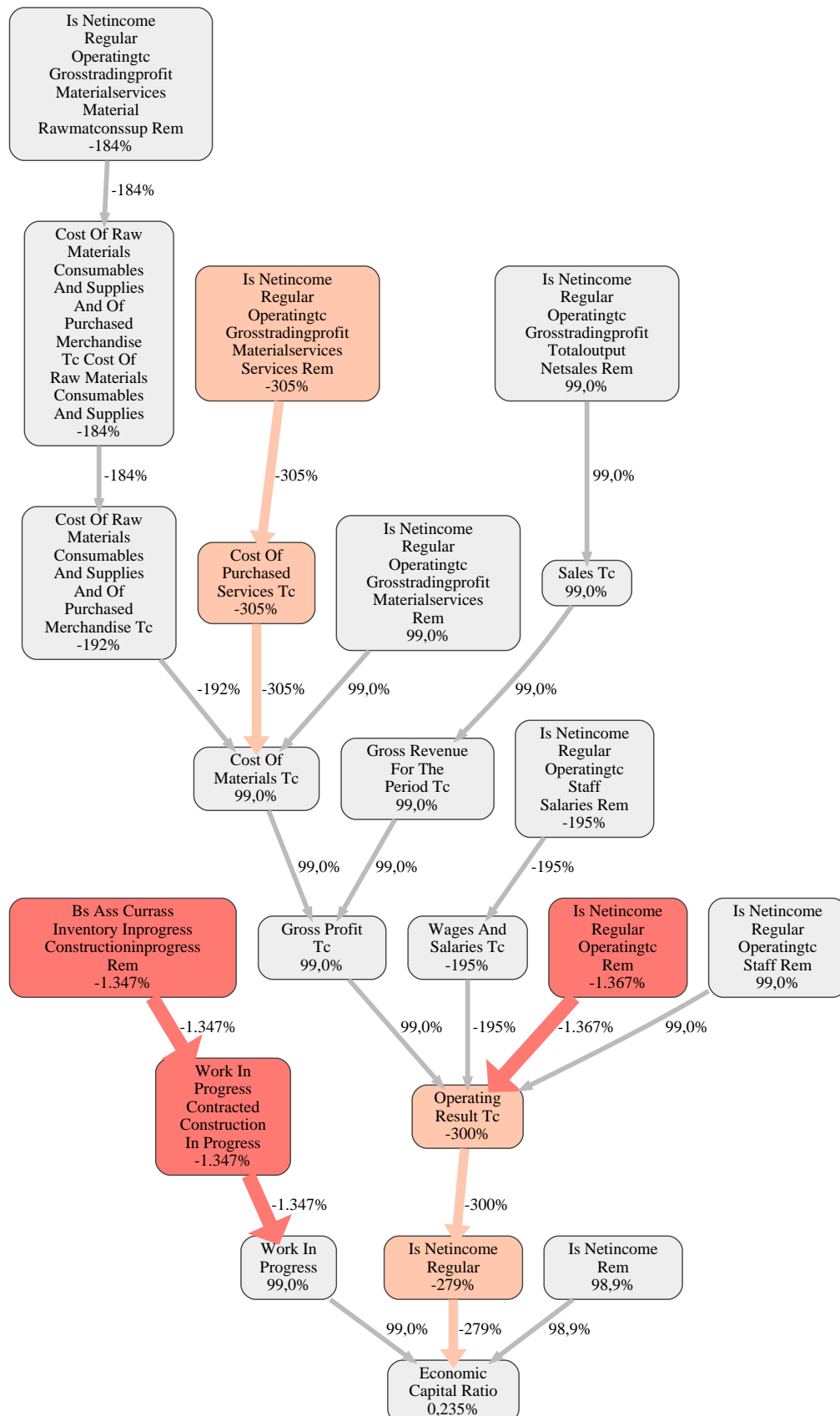

The greatest strength of Swietelsky Baugesellschaft m b H compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 99% points. The greatest weakness of Swietelsky Baugesellschaft m b H is the variable Is Netincome Regular Operatingtc Rem, reducing the Economic Capital Ratio by 1.367% points.

The company's Economic Capital Ratio, given in the ranking table, is 99%, being 0,23% points above the market average of 99%.
