The greatest strength of Lim Hoch und Tiefbau GmbH compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 67% points. The greatest weakness of Lim Hoch und Tiefbau GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 147% points.

The company's Economic Capital Ratio, given in the ranking table, is 70%, being 29% points below the market average of 99%.
