The greatest strength of Otto Wulff Bauunternehmung GmbH Konzern compared to the market average is the variable Bs Ass Currass Inventory Inprogress Rem, increasing the Economic Capital Ratio by 82% points. The greatest weakness of Otto Wulff Bauunternehmung GmbH Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Services Rem, reducing the Economic Capital Ratio by 94% points.

The company's Economic Capital Ratio, given in the ranking table, is 105%, being 5,9% points above the market average of 99%.
