



The relative strengths and weaknesses of Koska Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Koska Bau GmbH compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 125% points. The greatest weakness of Koska Bau GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 806% points.

The company's Economic Capital Ratio, given in the ranking table, is 125%, being 28% points above the market average of 97%.
