The greatest strength of Lim Hoch und Tiefbau GmbH compared to the market average is the variable Work In Progress, increasing the Economic Capital Ratio by 69% points. The greatest weakness of Lim Hoch und Tiefbau GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, reducing the Economic Capital Ratio by 137% points.

The company's Economic Capital Ratio, given in the ranking table, is 73%, being 24% points below the market average of 97%.
