



The relative strengths and weaknesses of Cadolto Modulbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Cadolto Modulbau GmbH compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 281% points. The greatest weakness of Cadolto Modulbau GmbH is the variable Bs Eqliab Liab Shareholders Rem, reducing the Economic Capital Ratio by 165% points.

The company's Economic Capital Ratio, given in the ranking table, is 309%, being 213% points above the market average of 97%.
