The greatest strength of Hanova Wohnen GmbH compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 68% points. The greatest weakness of Hanova Wohnen GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 283% points.

The company's Economic Capital Ratio, given in the ranking table, is 68%, being 29% points below the market average of 97%.
