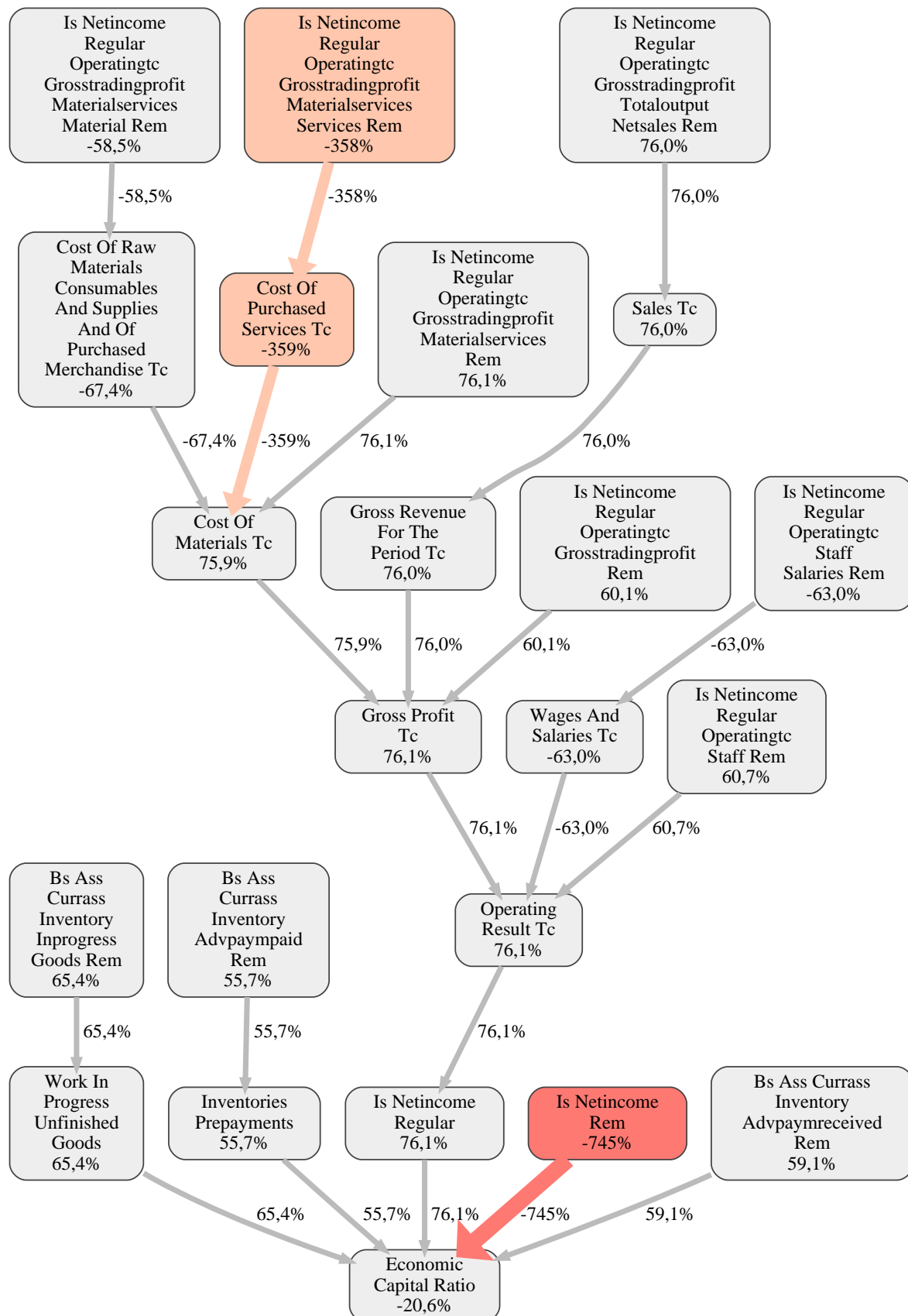

The greatest strength of Markgraf Familien GmbH Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 76% points. The greatest weakness of Markgraf Familien GmbH Konzern is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 745% points.

The company's Economic Capital Ratio, given in the ranking table, is 76%, being 21% points below the market average of 97%.
