The greatest strength of VSTR AG Rodewisch Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 84% points. The greatest weakness of VSTR AG Rodewisch Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, reducing the Economic Capital Ratio by 487% points.

The company's Economic Capital Ratio, given in the ranking table, is 84%, being 12% points below the market average of 97%.
