



The relative strengths and weaknesses of Goldbeck GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Goldbeck GmbH Konzern compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 153% points. The greatest weakness of Goldbeck GmbH Konzern is the variable Is Netincome Regular Operatingtc Rem, reducing the Economic Capital Ratio by 1.014% points.

The company's Economic Capital Ratio, given in the ranking table, is 153%, being 57% points above the market average of 97%.
