



The relative strengths and weaknesses of Joachim Nesseler Geschäftsführungsgesellschaft mbh Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Joachim Nesseler Geschäftsführungsgesellschaft mbh Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 117% points. The greatest weakness of Joachim Nesseler Geschäftsführungsgesellschaft mbh Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, reducing the Economic Capital Ratio by 638% points.

The company's Economic Capital Ratio, given in the ranking table, is 117%, being 21% points above the market average of 97%.
