



The relative strengths and weaknesses of B O Bauholding GmbH Vormals EB Bauholding GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of B O Bauholding GmbH Vormals EB Bauholding GmbH Konzern compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 62% points. The greatest weakness of B O Bauholding GmbH Vormals EB Bauholding GmbH Konzern is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 319% points.

The company's Economic Capital Ratio, given in the ranking table, is 62%, being 35% points below the market average of 97%.
