The greatest strength of Pfeiffer GmbH Konzern compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 88% points. The greatest weakness of Pfeiffer GmbH Konzern is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 436% points.

The company's Economic Capital Ratio, given in the ranking table, is 88%, being 8,1% points below the market average of 97%.
