

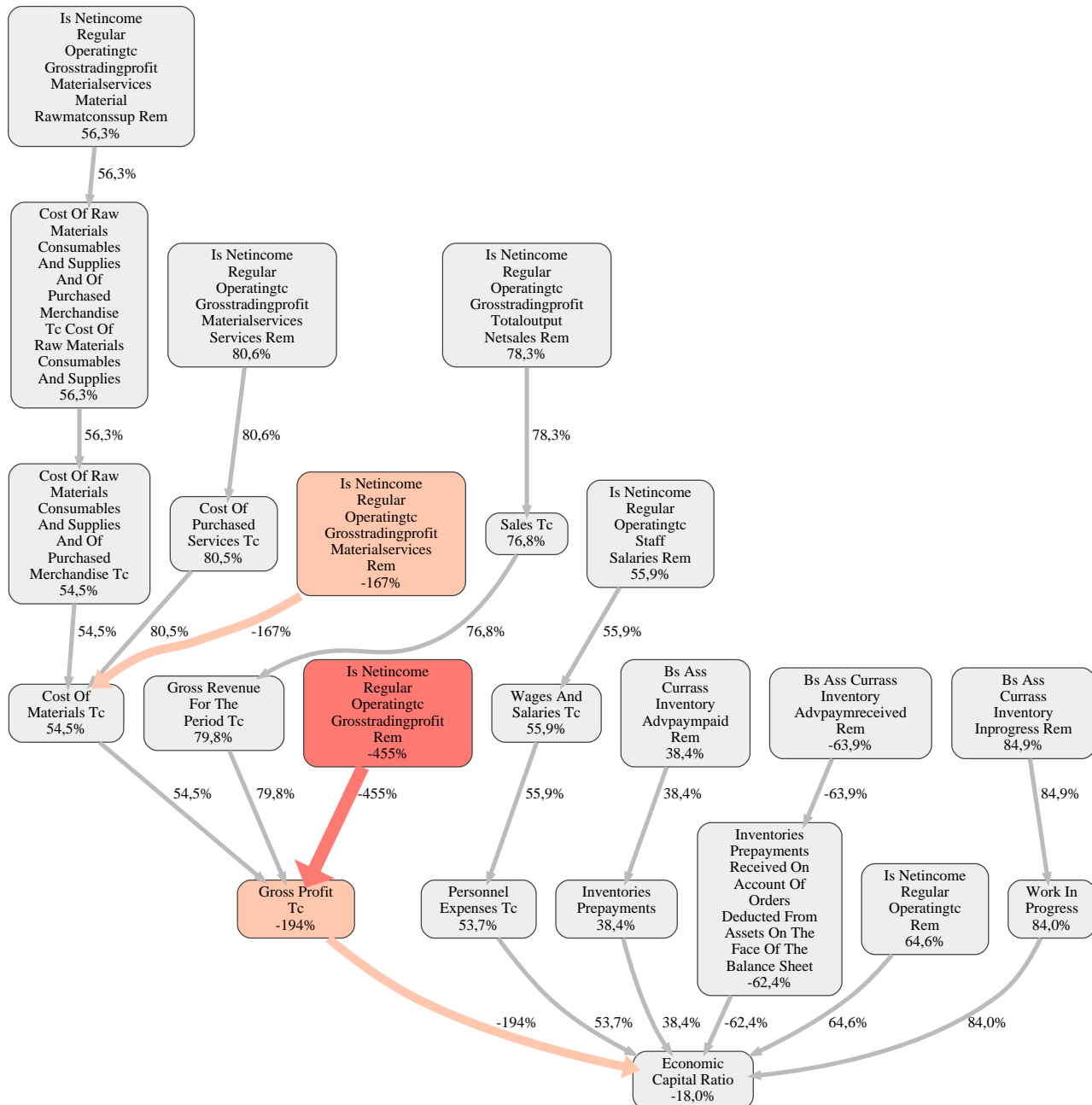

The relative strengths and weaknesses of Lambert Schlun GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Lambert Schlun GmbH Co KG compared to the market average is the variable Bs Ass Currass Inventory Inprogress Rem, increasing the Economic Capital Ratio by 85% points. The greatest weakness of Lambert Schlun GmbH Co KG is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, reducing the Economic Capital Ratio by 455% points.

The company's Economic Capital Ratio, given in the ranking table, is 85%, being 18% points below the market average of 103%.
