

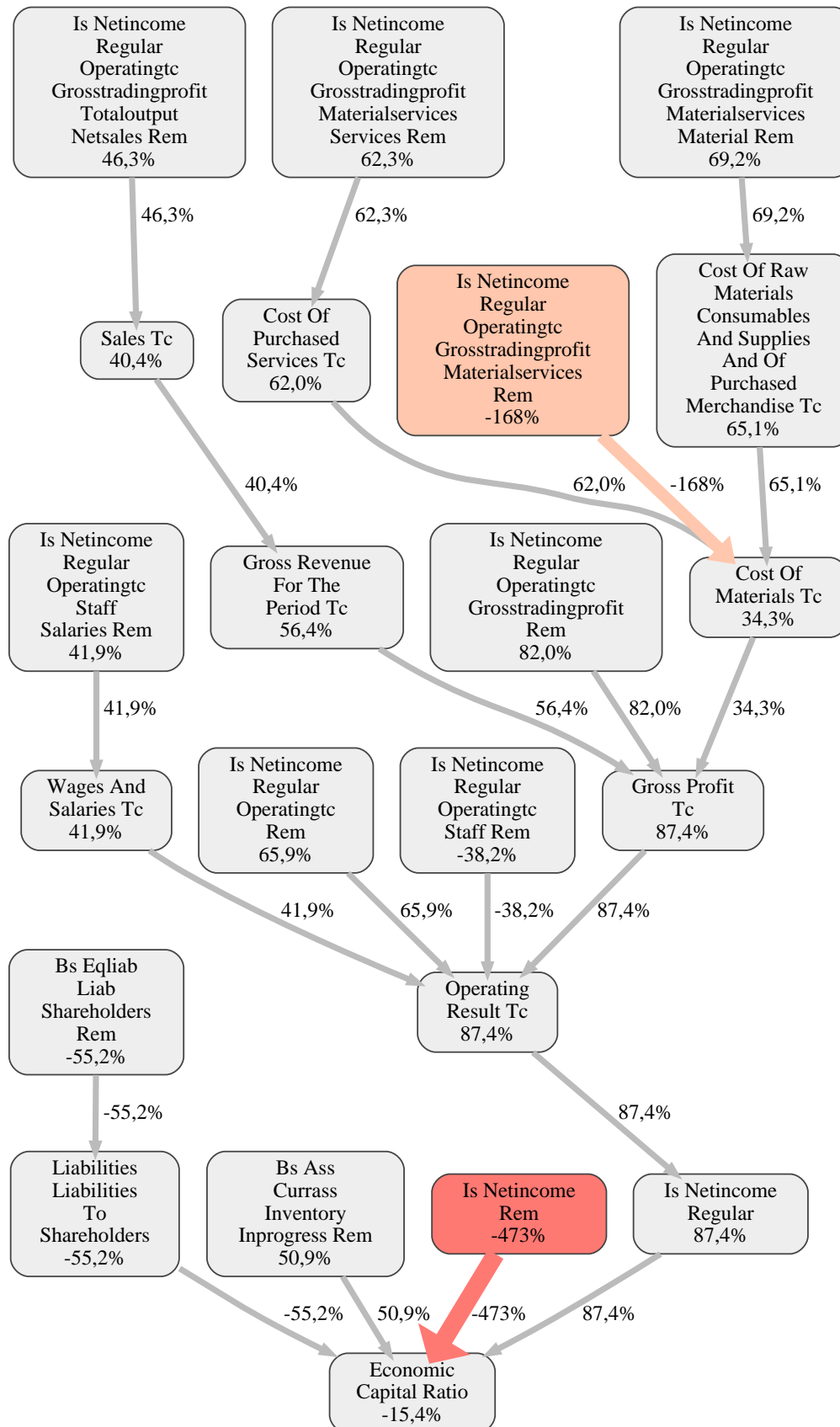

The relative strengths and weaknesses of Willy Dohmen GmbH Co KG Tief Straßen Hoch und Stahlbetonbau are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Willy Dohmen GmbH Co KG Tief Straßen Hoch und Stahlbetonbau compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 87% points. The greatest weakness of Willy Dohmen GmbH Co KG Tief Straßen Hoch und Stahlbetonbau is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 473% points.

The company's Economic Capital Ratio, given in the ranking table, is 87%, being 15% points below the market average of 103%.
