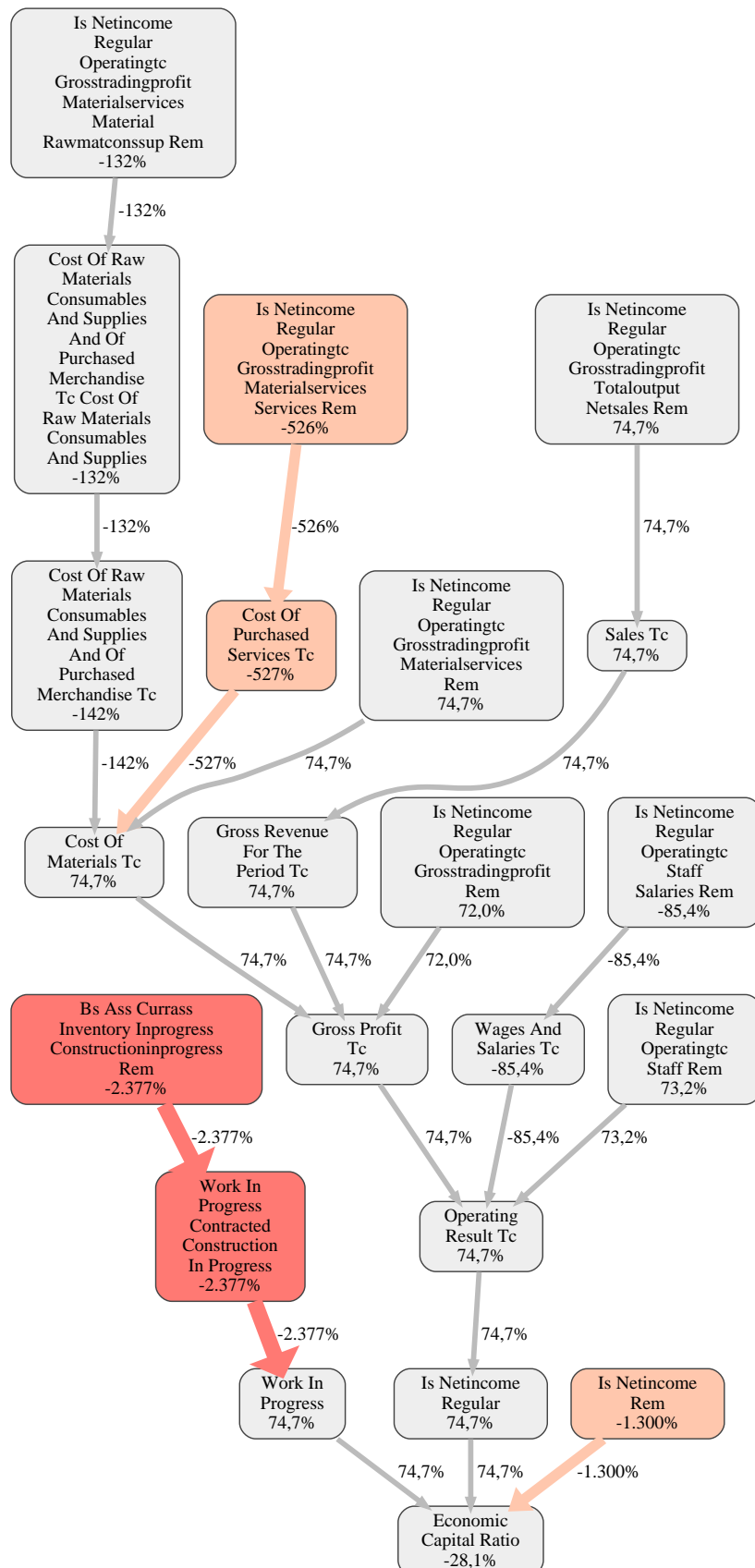

The greatest strength of Otto Mühlherr Baugesellschaft mbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 75% points. The greatest weakness of Otto Mühlherr Baugesellschaft mbH is the variable Bs Ass Currass Inventory Inprogress Constructioninprogress Rem, reducing the Economic Capital Ratio by 2.377% points.

The company's Economic Capital Ratio, given in the ranking table, is 75%, being 28% points below the market average of 103%.
