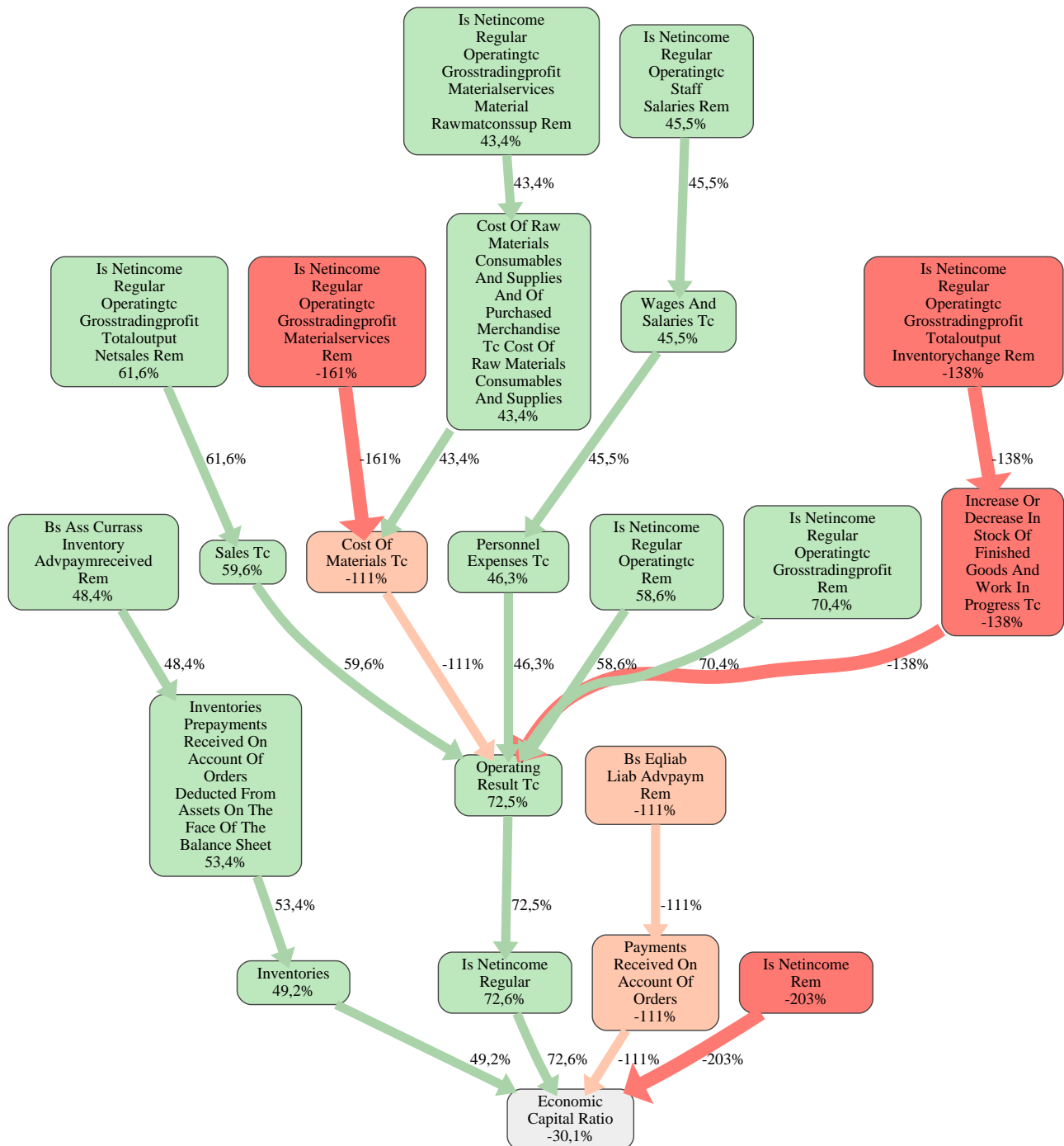

The greatest strength of Bauunternehmung Peter Igl GmbH compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 73% points. The greatest weakness of Bauunternehmung Peter Igl GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 203% points.

The company's Economic Capital Ratio, given in the ranking table, is 73%, being 30% points below the market average of 103%.
