



The relative strengths and weaknesses of Wohlfühlhaus Bau GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohlfühlhaus Bau GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 0,011% points. The greatest weakness of Wohlfühlhaus Bau GmbH Co KG is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 356% points.

The company's Economic Capital Ratio, given in the ranking table, is 0,011%, being 103% points below the market average of 103%.
