

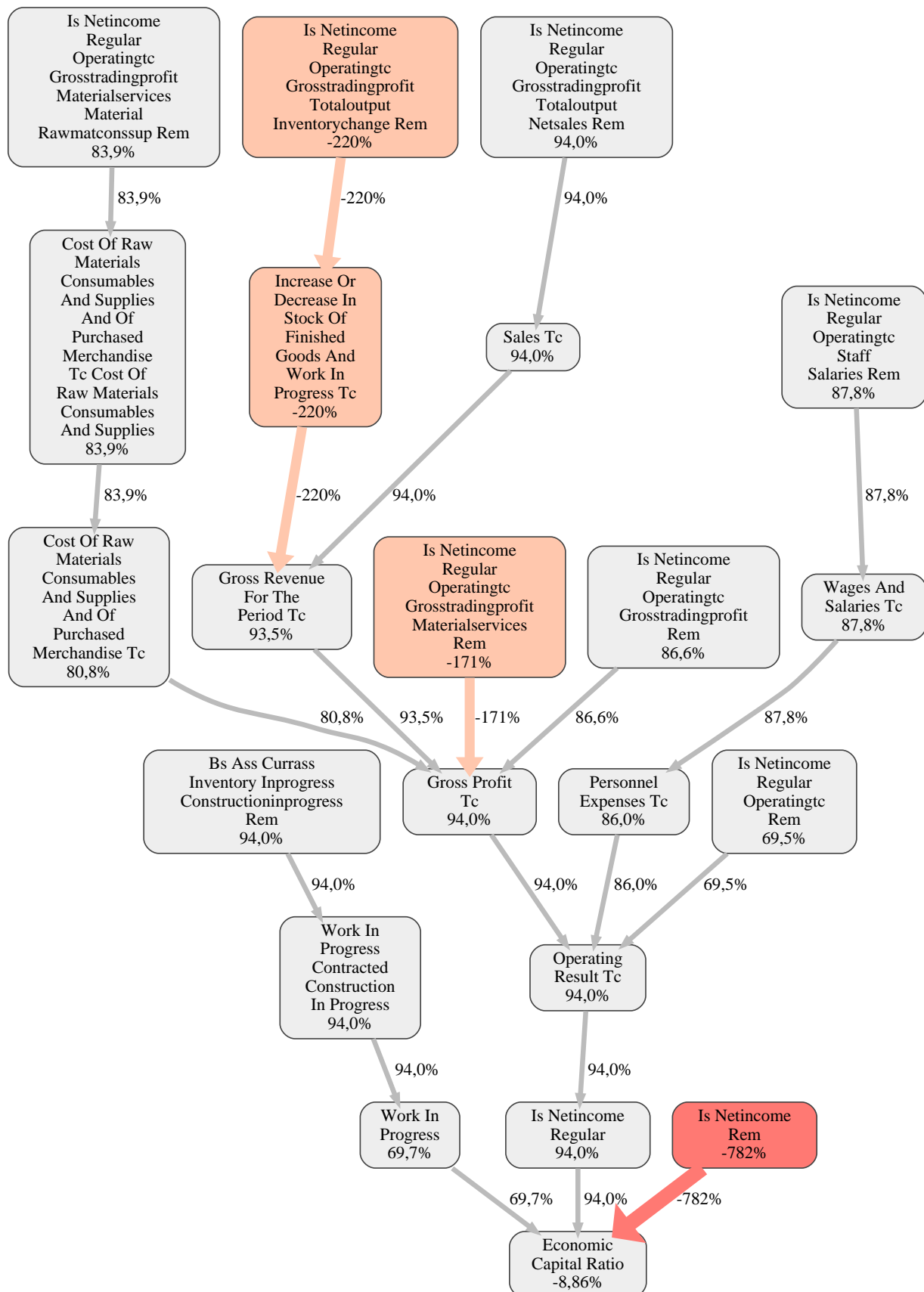

The relative strengths and weaknesses of Bauunternehmung Hermann GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Hermann GmbH compared to the market average is the variable Bs Ass Currass Inventory Inprogress Constructioninprogress Rem, increasing the Economic Capital Ratio by 94% points. The greatest weakness of Bauunternehmung Hermann GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 782% points.

The company's Economic Capital Ratio, given in the ranking table, is 94%, being 8,9% points below the market average of 103%.
