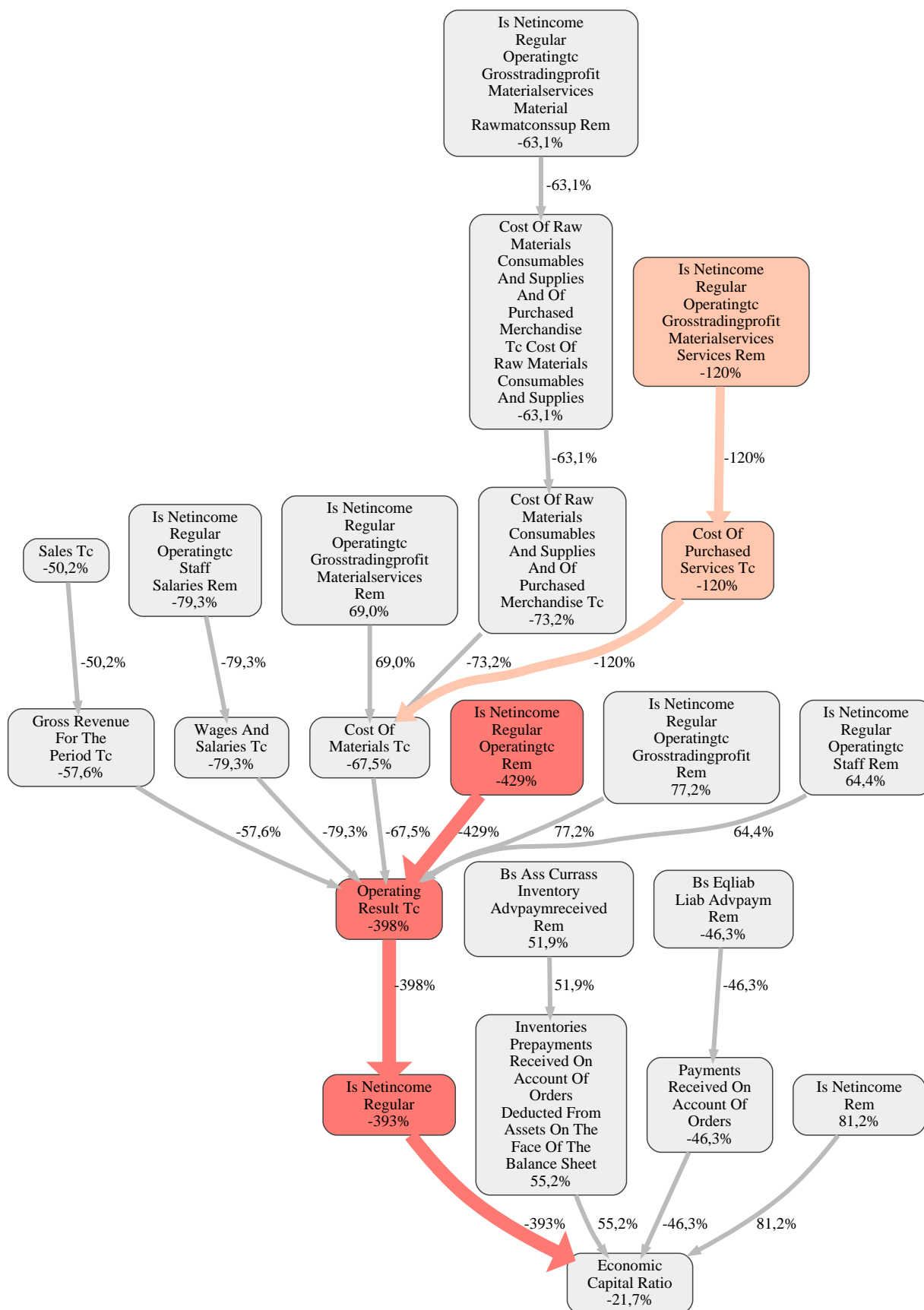

The greatest strength of Weberhaus GmbH Co KG compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 81% points. The greatest weakness of Weberhaus GmbH Co KG is the variable Is Netincome Regular Operatingtc Rem, reducing the Economic Capital Ratio by 429% points.

The company's Economic Capital Ratio, given in the ranking table, is 81%, being 22% points below the market average of 103%.
