

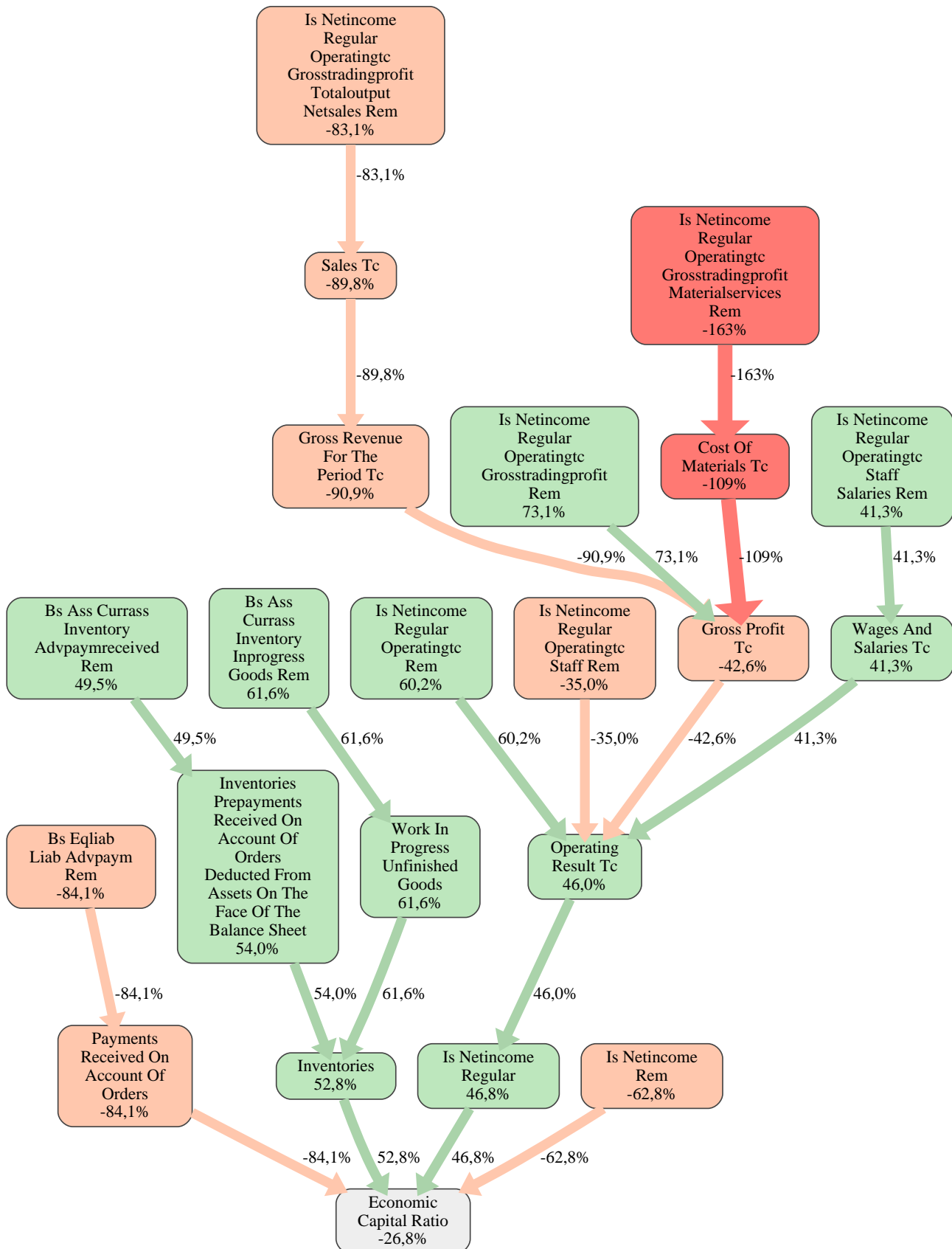

The relative strengths and weaknesses of Lim Hoch und Tiefbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Lim Hoch und Tiefbau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, increasing the Economic Capital Ratio by 73% points. The greatest weakness of Lim Hoch und Tiefbau GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, reducing the Economic Capital Ratio by 163% points.

The company's Economic Capital Ratio, given in the ranking table, is 76%, being 27% points below the market average of 103%.
