

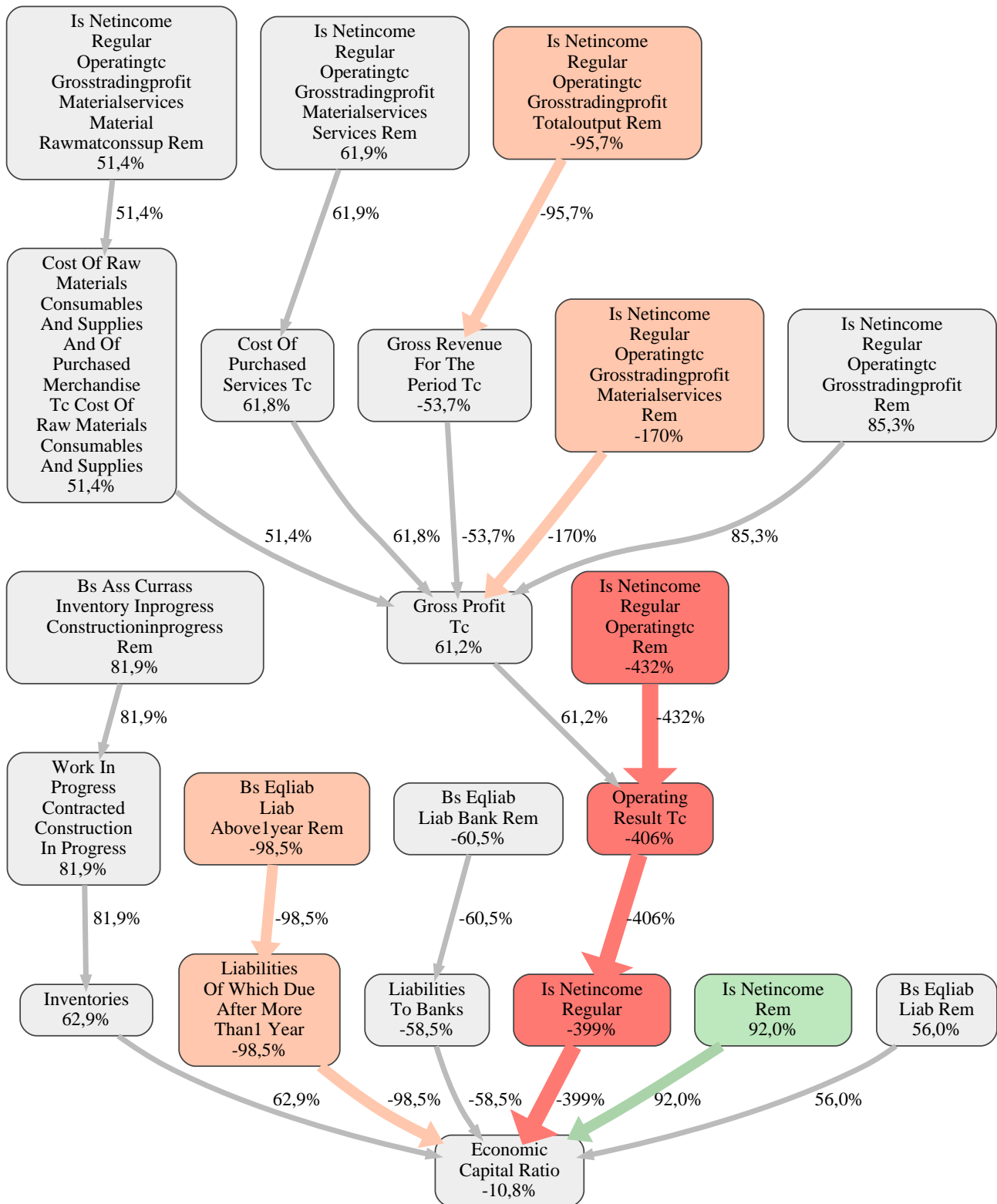

The relative strengths and weaknesses of Monte Hochbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Monte Hochbau GmbH compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 92% points. The greatest weakness of Monte Hochbau GmbH is the variable Is Netincome Regular Operatingtc Rem, reducing the Economic Capital Ratio by 432% points.

The company's Economic Capital Ratio, given in the ranking table, is 92%, being 11% points below the market average of 103%.
