The greatest strength of Bonava Wohnbau GmbH compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 32% points. The greatest weakness of Bonava Wohnbau GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 243% points.

The company's Economic Capital Ratio, given in the ranking table, is 32%, being 71% points below the market average of 103%.
