

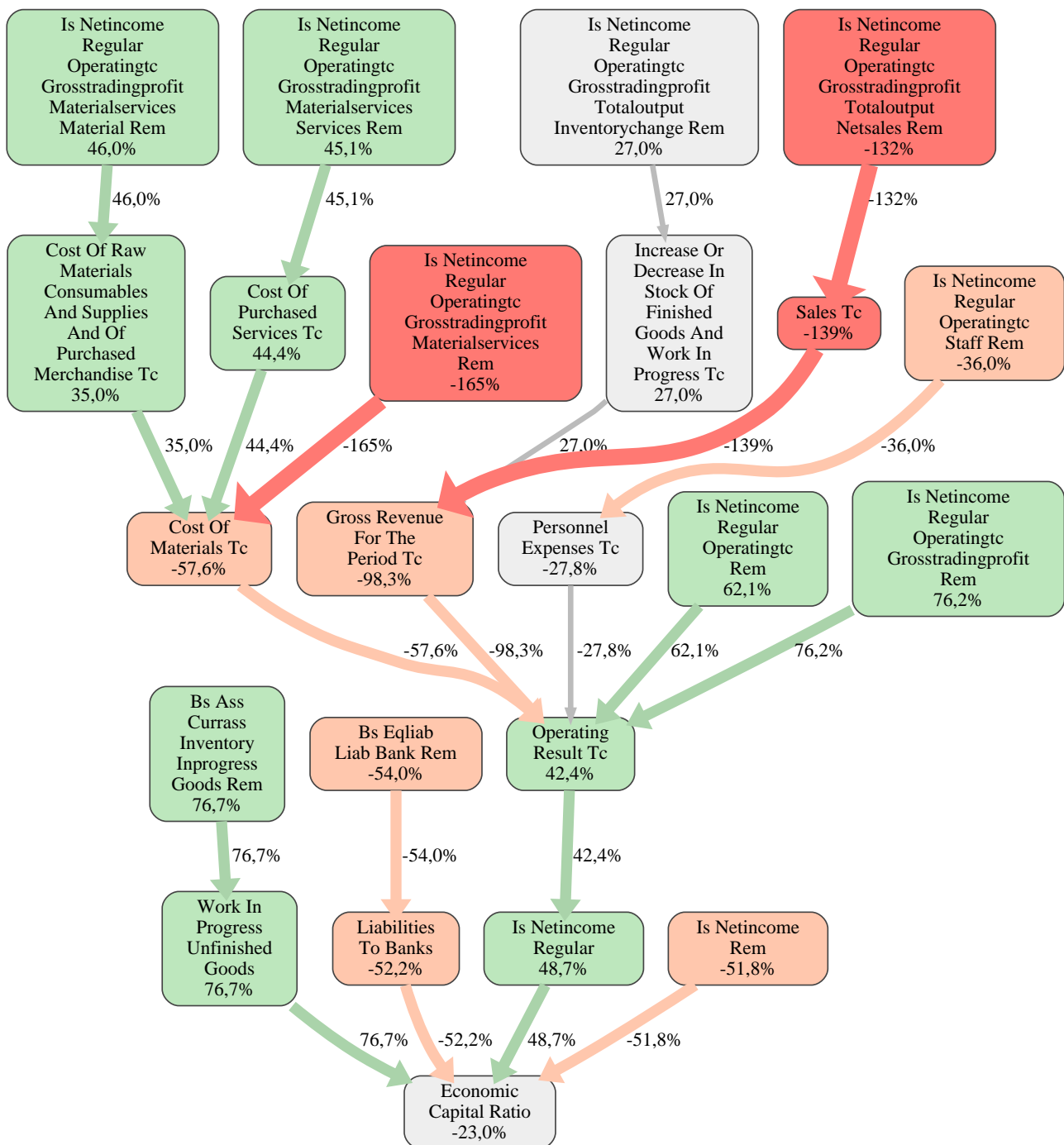

The relative strengths and weaknesses of Arning Bauunternehmung GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Arning Bauunternehmung GmbH Konzern compared to the market average is the variable Bs Ass Currass Inventory Inprogress Goods Rem, increasing the Economic Capital Ratio by 77% points. The greatest weakness of Arning Bauunternehmung GmbH Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, reducing the Economic Capital Ratio by 165% points.

The company's Economic Capital Ratio, given in the ranking table, is 80%, being 23% points below the market average of 103%.
