

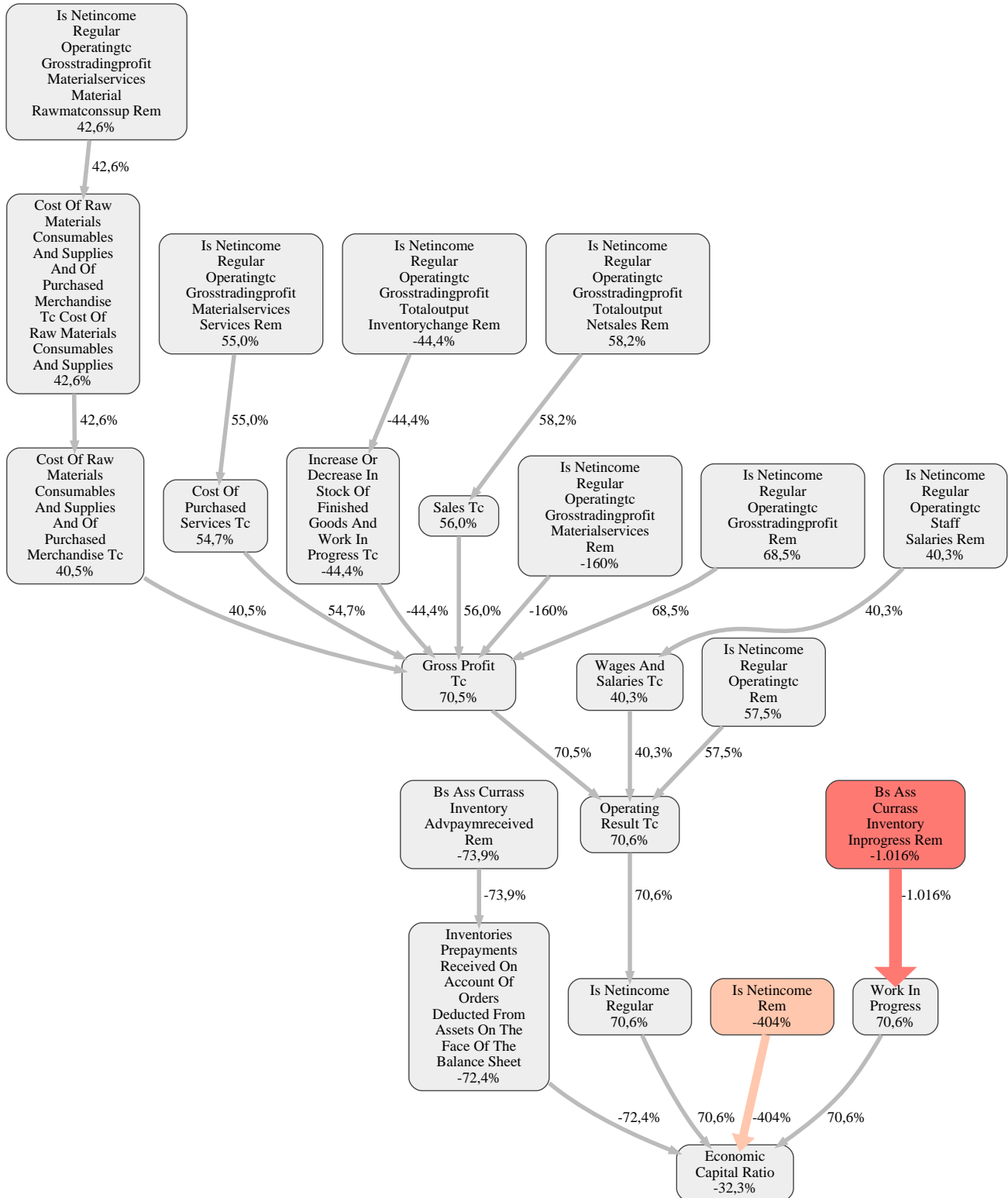

The relative strengths and weaknesses of Himmel u Papesch Bauunternehmung GmbH Co KG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Himmel u Papesch Bauunternehmung GmbH Co KG Konzern compared to the market average is the variable Work In Progress, increasing the Economic Capital Ratio by 71% points. The greatest weakness of Himmel u Papesch Bauunternehmung GmbH Co KG Konzern is the variable Bs Ass Currass Inventory Inprogress Rem, reducing the Economic Capital Ratio by 1.016% points.

The company's Economic Capital Ratio, given in the ranking table, is 71%, being 32% points below the market average of 103%.
