

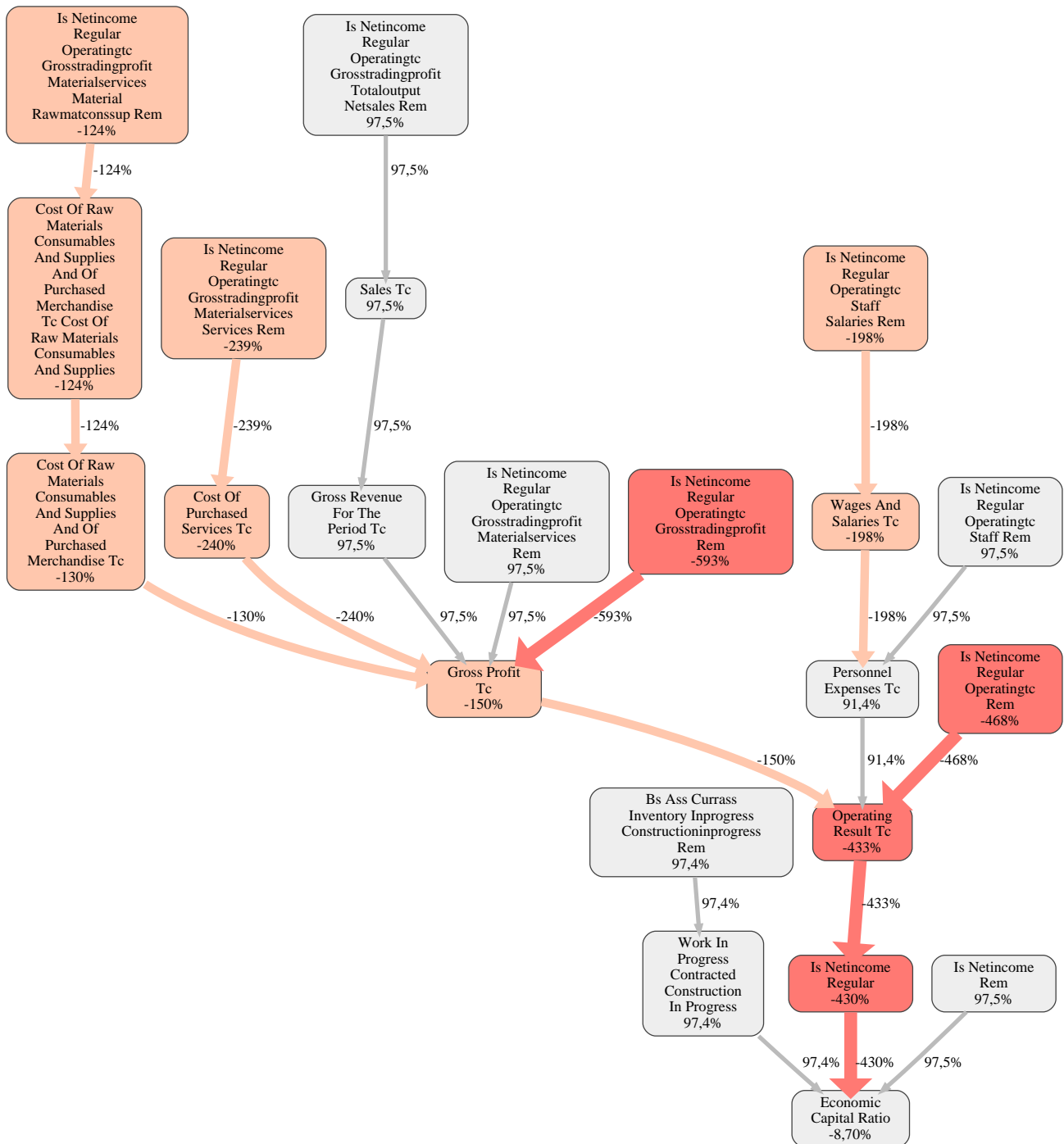

The greatest strength of Hans Graf Bauunternehmung GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 97% points. The greatest weakness of Hans Graf Bauunternehmung GmbH Co KG is the variable Is Netincome Regular Operatingtc Grosstradingprofit Rem, reducing the Economic Capital Ratio by 593% points.

The company's Economic Capital Ratio, given in the ranking table, is 97%, being 8,7% points below the market average of 106%.
