



The relative strengths and weaknesses of Ludwig Pfeiffer Hoch und Tiefbau GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Ludwig Pfeiffer Hoch und Tiefbau GmbH Co KG compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 67% points. The greatest weakness of Ludwig Pfeiffer Hoch und Tiefbau GmbH Co KG is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 194% points.

The company's Economic Capital Ratio, given in the ranking table, is 68%, being 39% points below the market average of 106%.
