

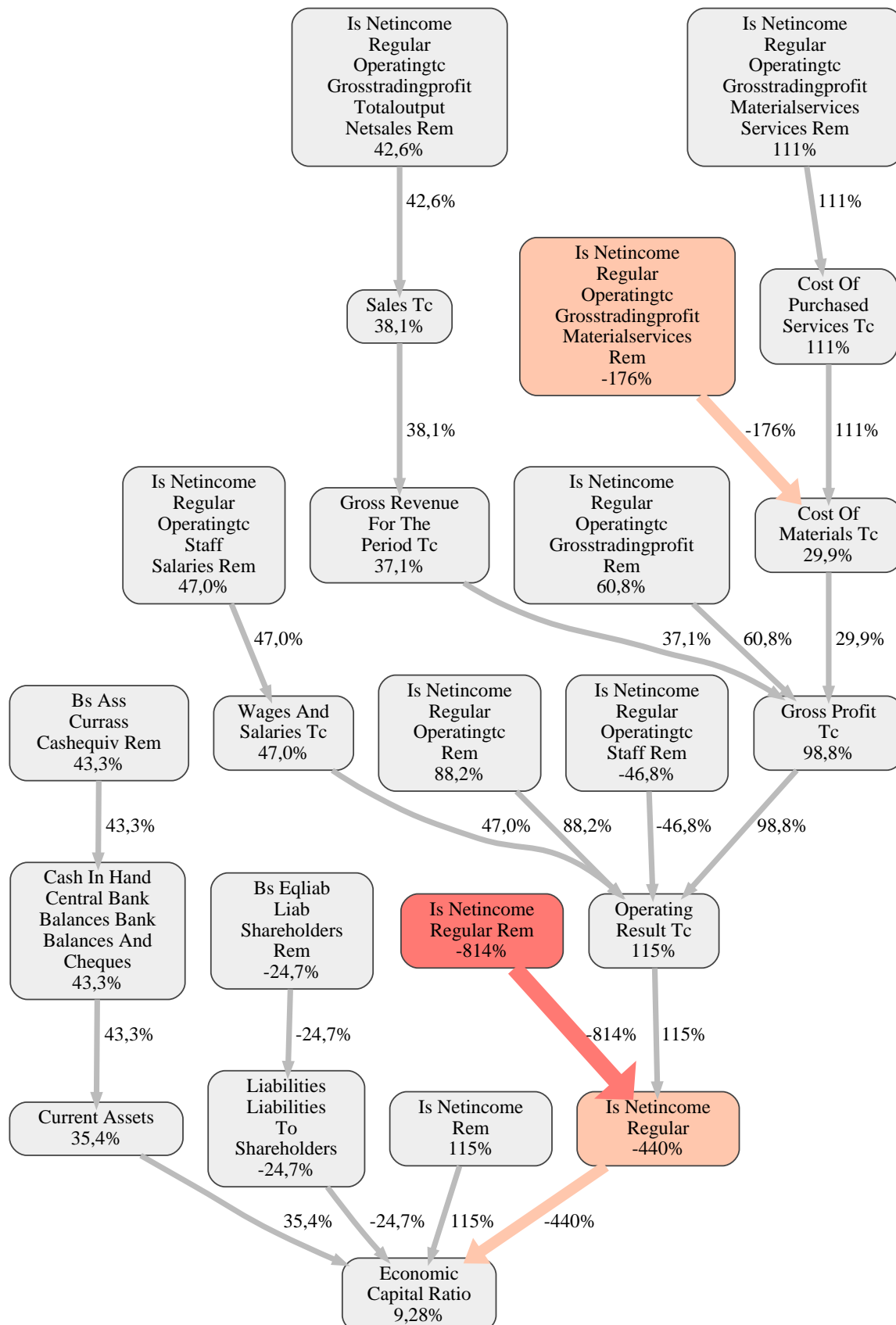

The relative strengths and weaknesses of Hetzel Sponheuer GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hetzel Sponheuer GmbH Co KG compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 115% points. The greatest weakness of Hetzel Sponheuer GmbH Co KG is the variable Is Netincome Regular Rem, reducing the Economic Capital Ratio by 814% points.

The company's Economic Capital Ratio, given in the ranking table, is 115%, being 9,3% points above the market average of 106%.
