



The relative strengths and weaknesses of Dogewo Dortmunder Gesellschaft für Wohnen mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Dogewo Dortmunder Gesellschaft für Wohnen mbH compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 53% points. The greatest weakness of Dogewo Dortmunder Gesellschaft für Wohnen mbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 449% points.

The company's Economic Capital Ratio, given in the ranking table, is 53%, being 53% points below the market average of 106%.
