The greatest strength of Willy Dohmen GmbH Co KG Tief Straßen Hoch und Stahlbetonbau compared to the market average is the variable Is Netincome Regular Operatingtc Rem, increasing the Economic Capital Ratio by 59% points. The greatest weakness of Willy Dohmen GmbH Co KG Tief Straßen Hoch und Stahlbetonbau is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, reducing the Economic Capital Ratio by 169% points.

The company's Economic Capital Ratio, given in the ranking table, is 82%, being 22% points below the market average of 103%.
