The greatest strength of Baugesellschaft Walter Hellmich GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Services Rem, increasing the Economic Capital Ratio by 102% points. The greatest weakness of Baugesellschaft Walter Hellmich GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, reducing the Economic Capital Ratio by 182% points.

The company's Economic Capital Ratio, given in the ranking table, is 124%, being 21% points above the market average of 103%.
