The greatest strength of Wohlfühlhaus Bau GmbH Co KG compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 45% points. The greatest weakness of Wohlfühlhaus Bau GmbH Co KG is the variable Operating Result Tc, reducing the Economic Capital Ratio by 444% points.

The company's Economic Capital Ratio, given in the ranking table, is 45%, being 59% points below the market average of 103%.
