

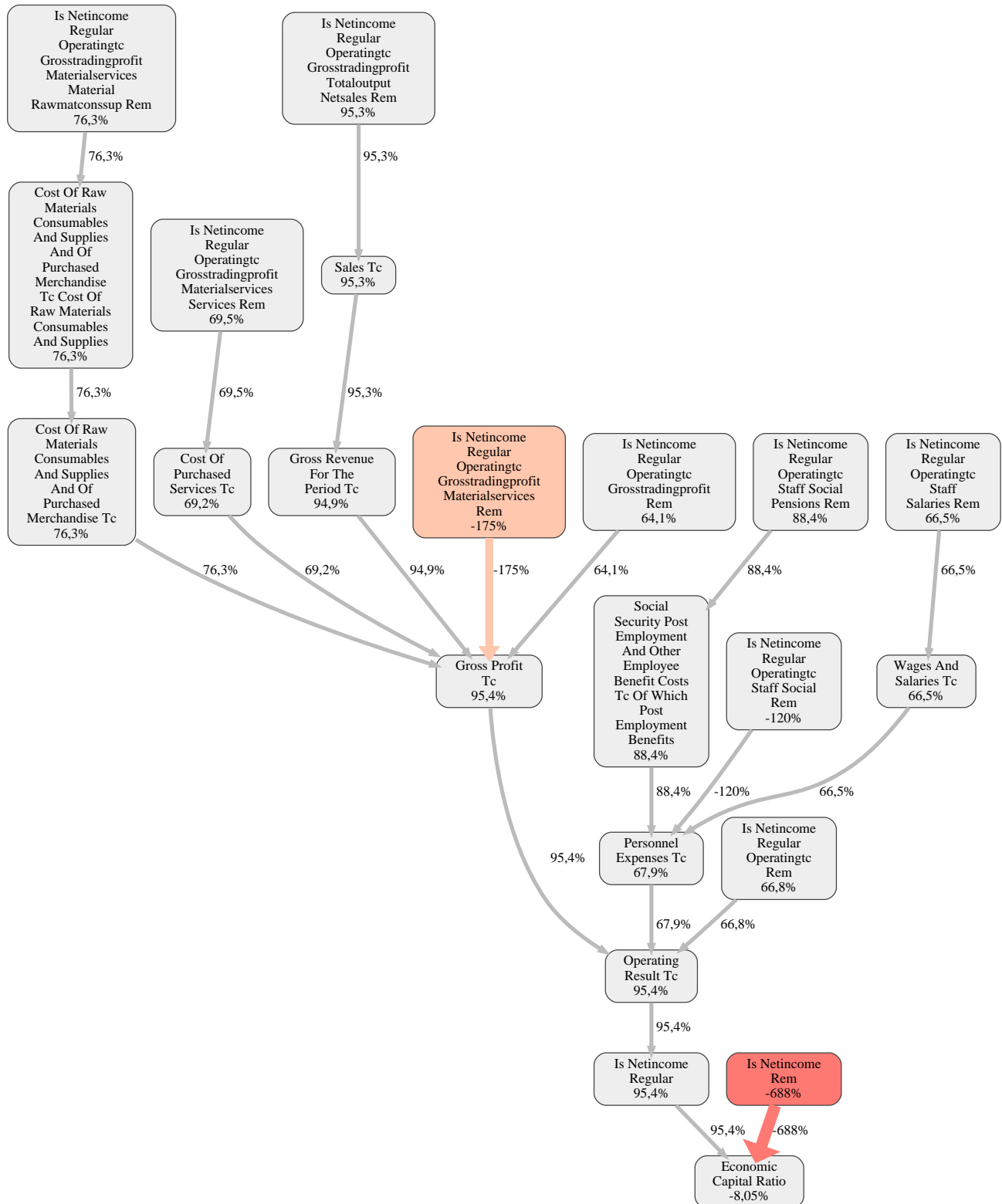

The relative strengths and weaknesses of Arlt Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Arlt Bauunternehmen GmbH compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 95% points. The greatest weakness of Arlt Bauunternehmen GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 688% points.

The company's Economic Capital Ratio, given in the ranking table, is 95%, being 8,0% points below the market average of 103%.
