

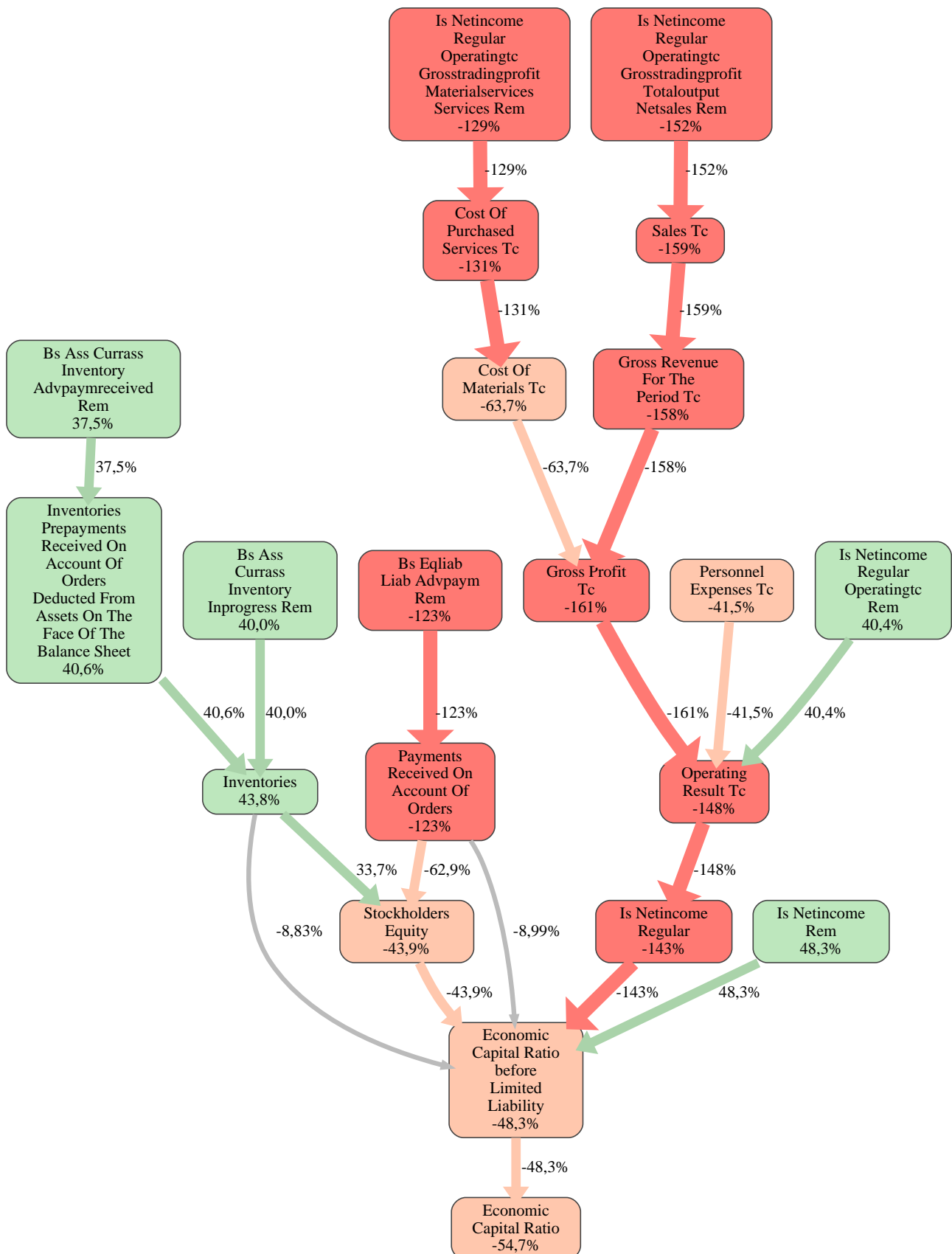

The relative strengths and weaknesses of GP Con GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of GP Con GmbH compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 48% points. The greatest weakness of GP Con GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 161% points.

The company's Economic Capital Ratio, given in the ranking table, is 49%, being 55% points below the market average of 103%.
