

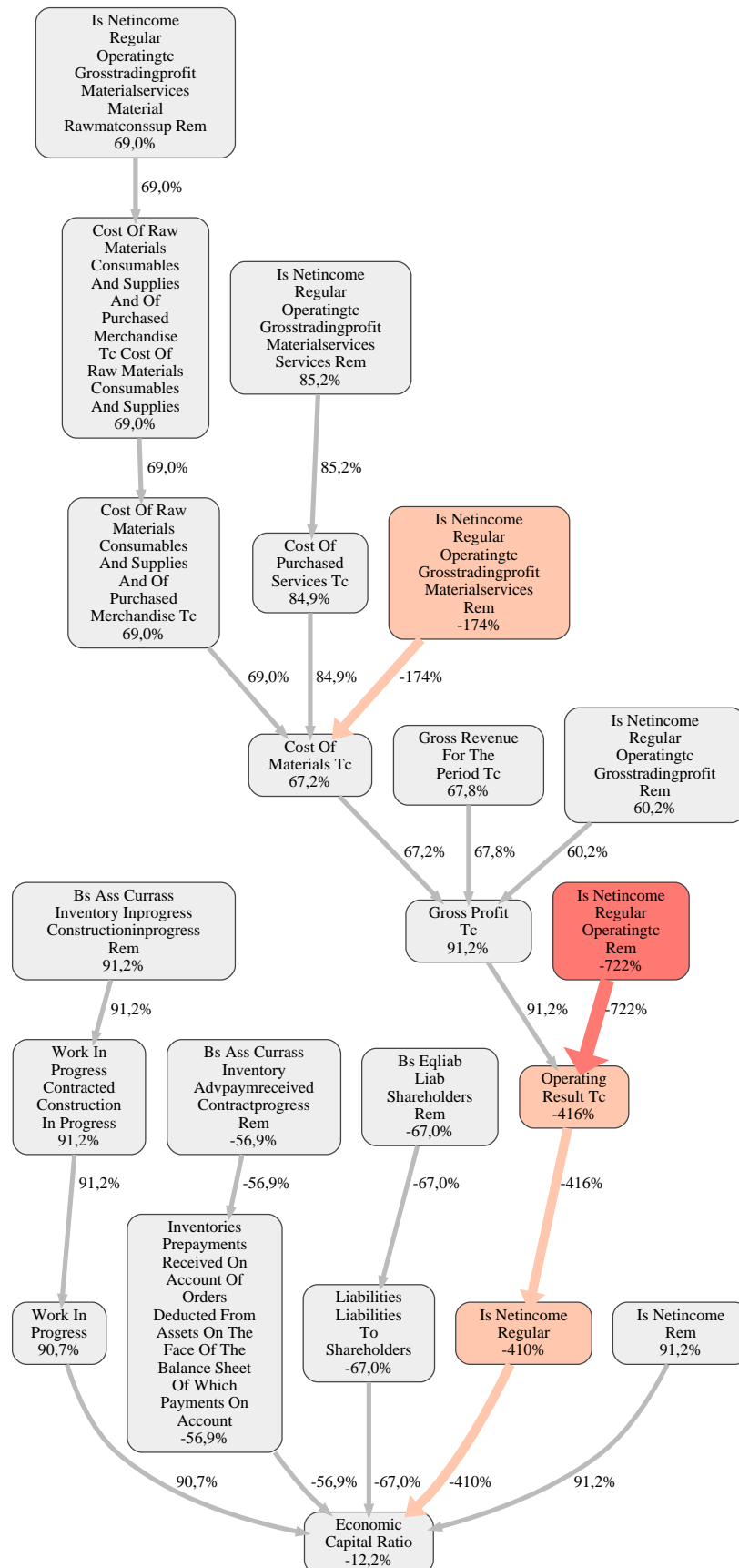

The greatest strength of Moser GmbH Co KG compared to the market average is the variable Bs Ass Currass Inventory Inprogress Constructioninprogress Rem, increasing the Economic Capital Ratio by 91% points. The greatest weakness of Moser GmbH Co KG is the variable Is Netincome Regular Operatingtc Rem, reducing the Economic Capital Ratio by 722% points.

The company's Economic Capital Ratio, given in the ranking table, is 91%, being 12% points below the market average of 103%.
