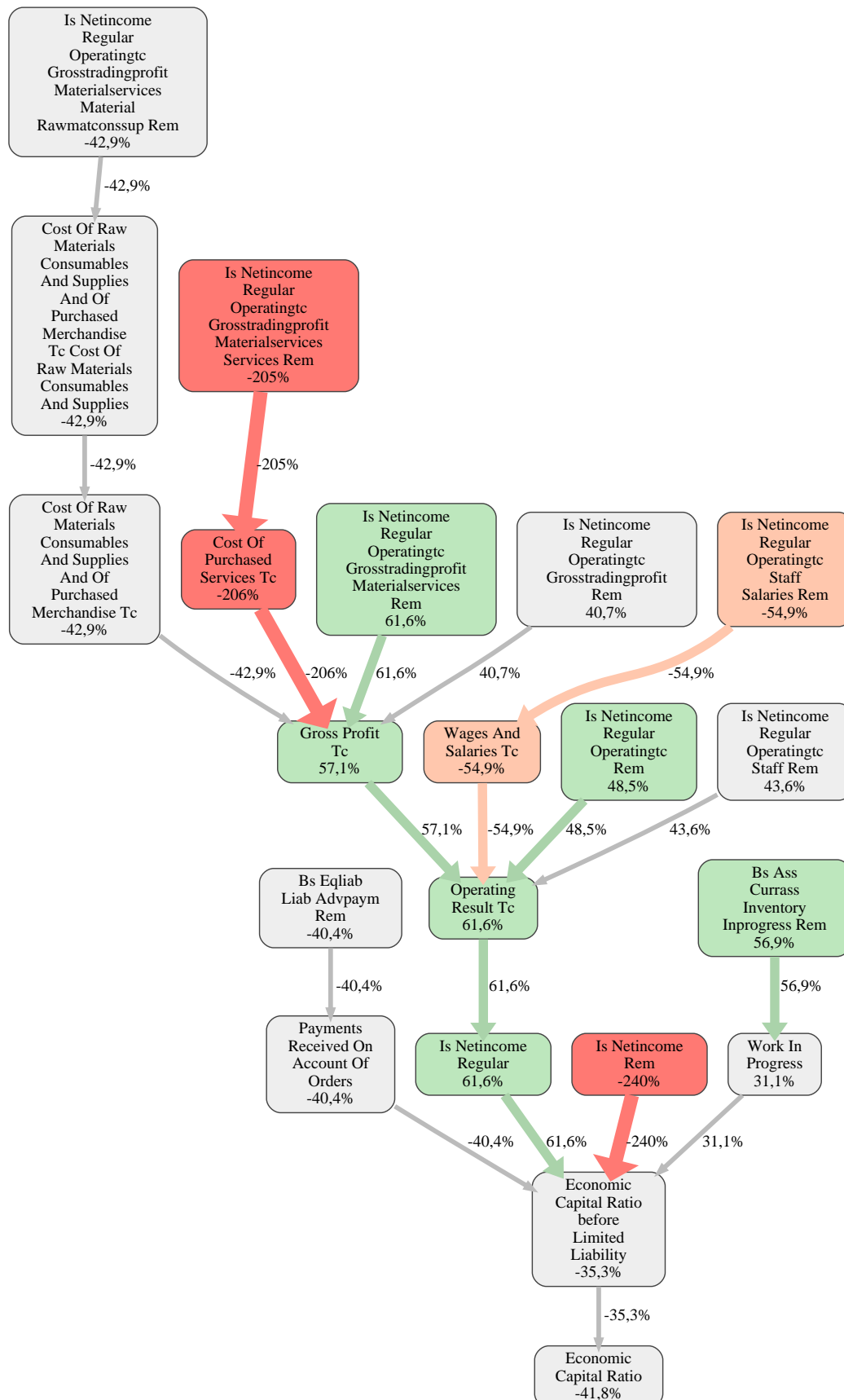

The greatest strength of Cadolto Modulbau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 62% points. The greatest weakness of Cadolto Modulbau GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 240% points.

The company's Economic Capital Ratio, given in the ranking table, is 62%, being 42% points below the market average of 103%.
