



The relative strengths and weaknesses of HBB Hanseatische Wohnungsbaugesellschaft mbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HBB Hanseatische Wohnungsbaugesellschaft mbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 589% points. The greatest weakness of HBB Hanseatische Wohnungsbaugesellschaft mbH Co KG is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 2.968% points.

The company's Economic Capital Ratio, given in the ranking table, is 589%, being 486% points above the market average of 103%.
