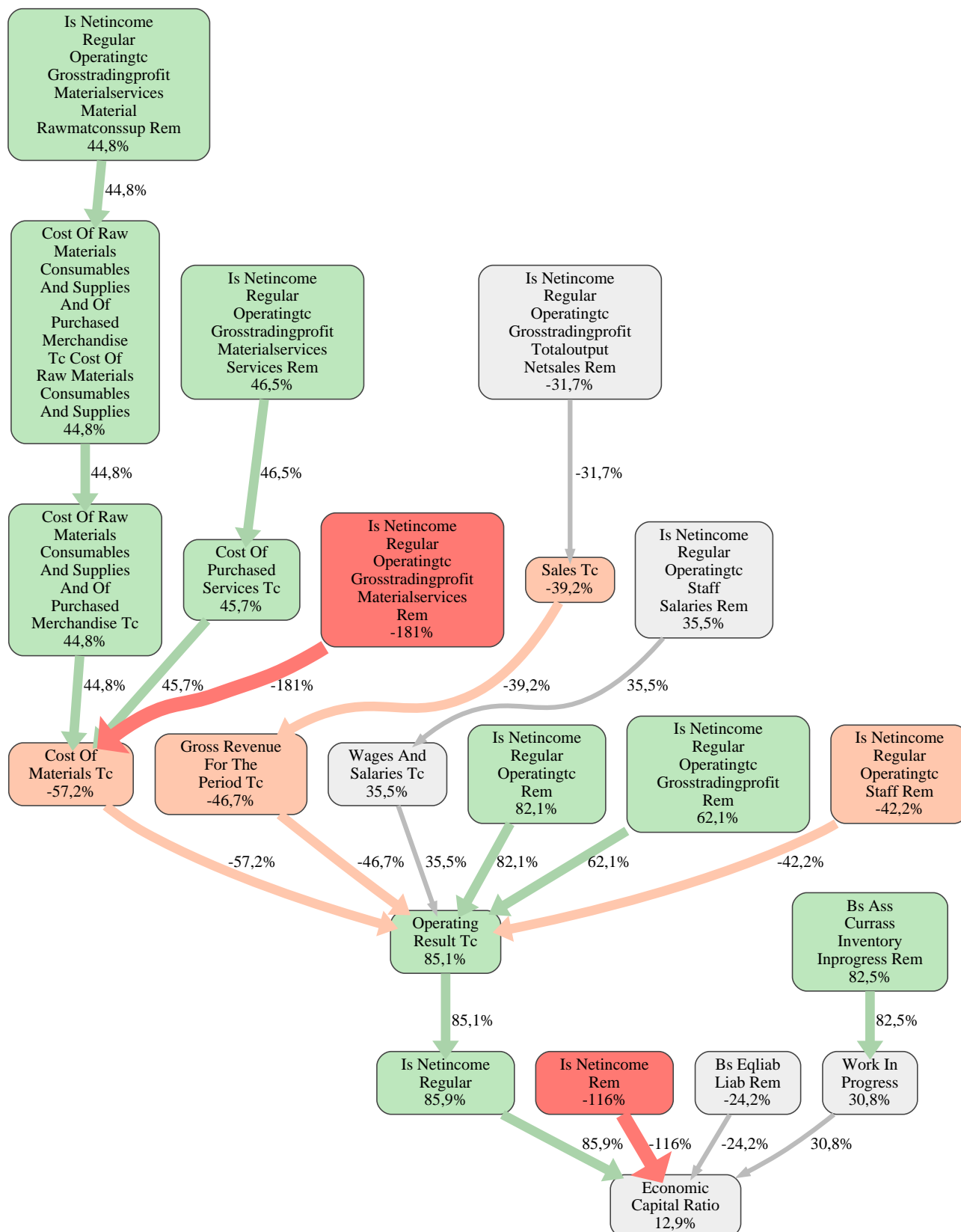

The greatest strength of Bickhardt Bau Aktiengesellschaft Konzern compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 86% points. The greatest weakness of Bickhardt Bau Aktiengesellschaft Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, reducing the Economic Capital Ratio by 181% points.

The company's Economic Capital Ratio, given in the ranking table, is 116%, being 13% points above the market average of 103%.
