

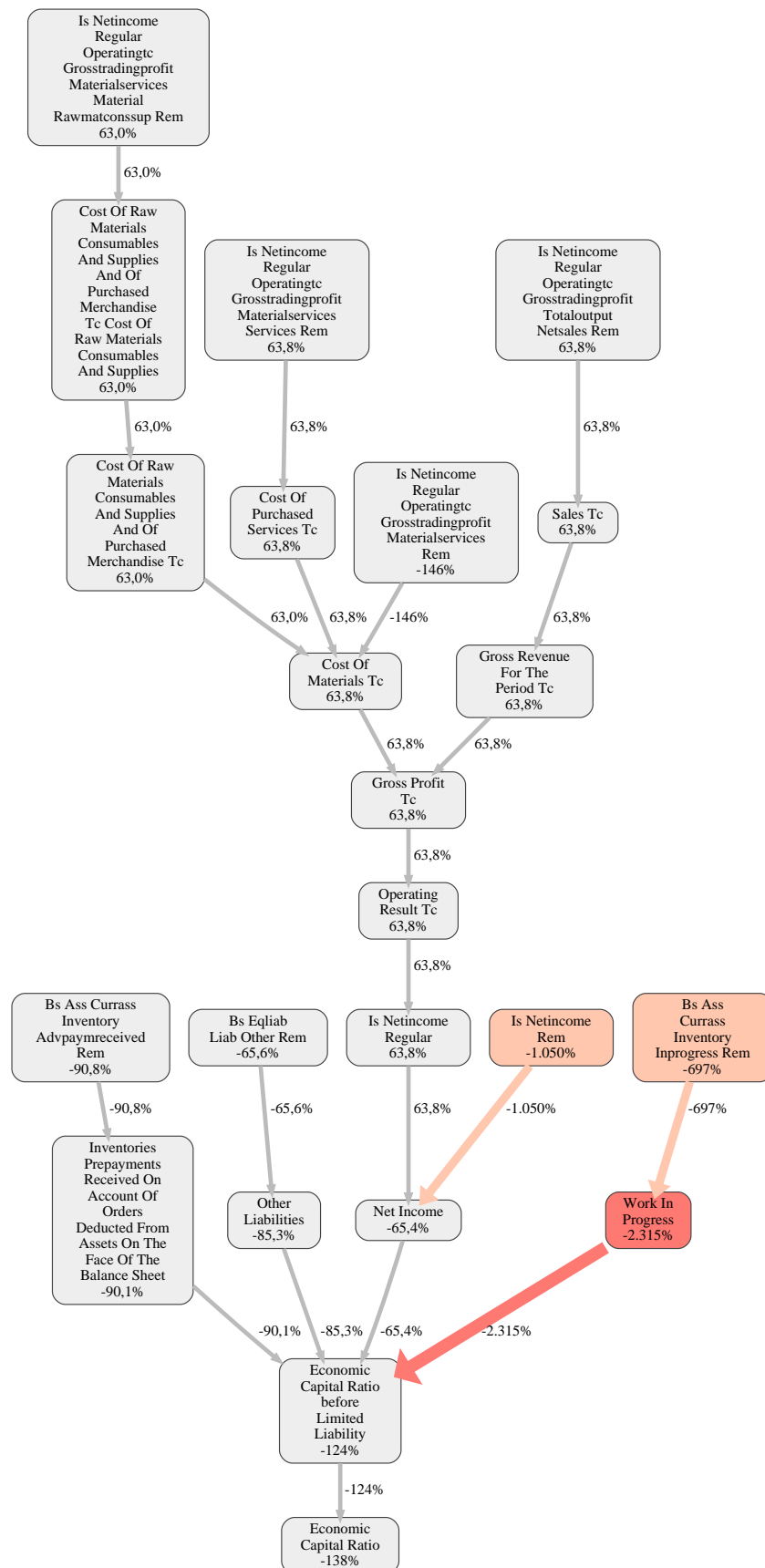

The relative strengths and weaknesses of Kögel Bau GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Kögel Bau GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Rem, increasing the Economic Capital Ratio by 64% points. The greatest weakness of Kögel Bau GmbH Co KG is the variable Work In Progress, reducing the Economic Capital Ratio by 2.315% points.

The company's Economic Capital Ratio, given in the ranking table, is 64%, being 138% points below the market average of 202%.
