The greatest strength of VSTR AG Rodewisch compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 100% points. The greatest weakness of VSTR AG Rodewisch is the variable Operating Result Tc, reducing the Economic Capital Ratio by 521% points.

The company's Economic Capital Ratio, given in the ranking table, is 100%, being 102% points below the market average of 202%.
