

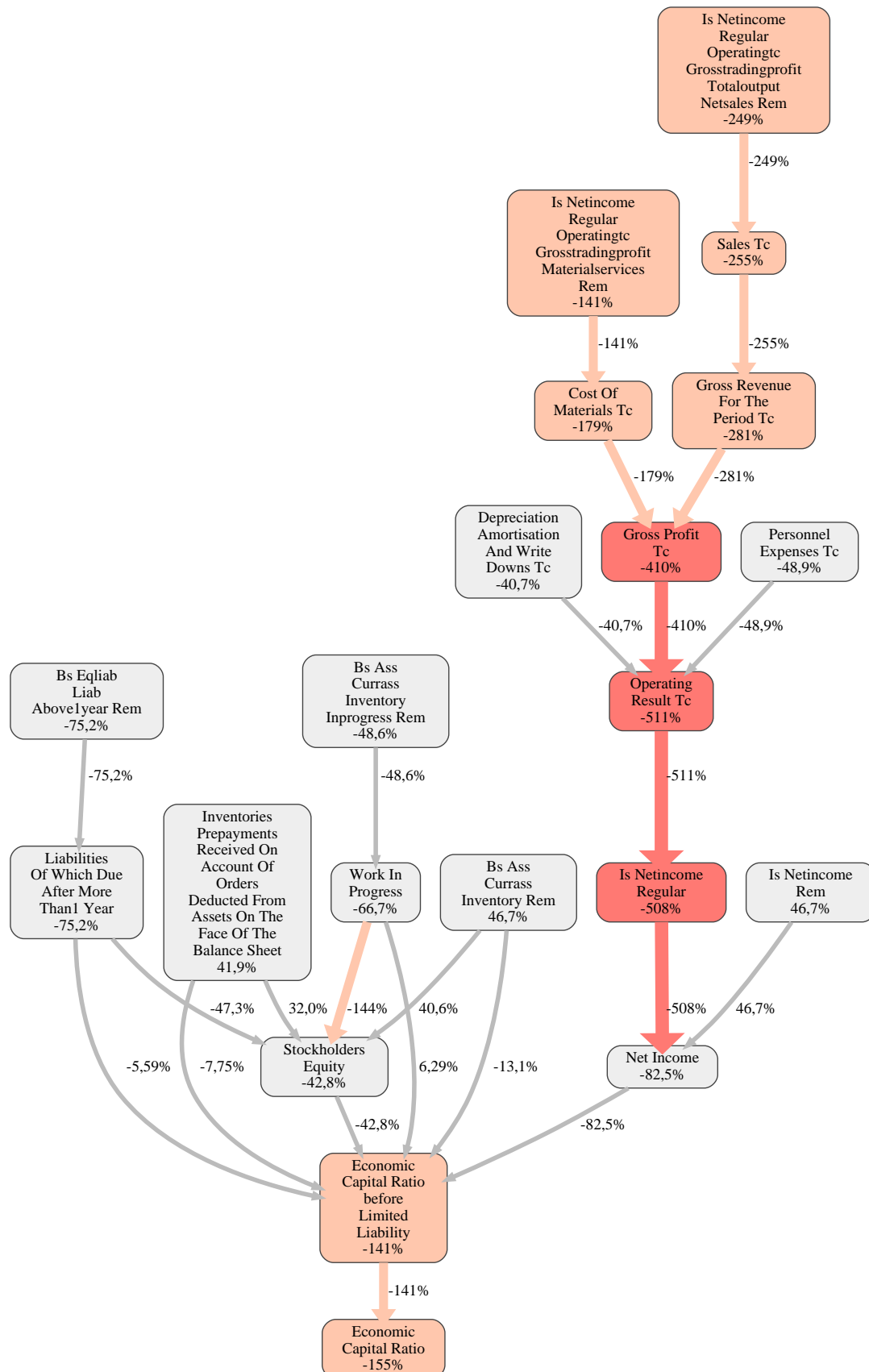

The relative strengths and weaknesses of Wohlfühlhaus Bau GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohlfühlhaus Bau GmbH Co KG compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 47% points. The greatest weakness of Wohlfühlhaus Bau GmbH Co KG is the variable Operating Result Tc, reducing the Economic Capital Ratio by 511% points.

The company's Economic Capital Ratio, given in the ranking table, is 47%, being 155% points below the market average of 202%.
