

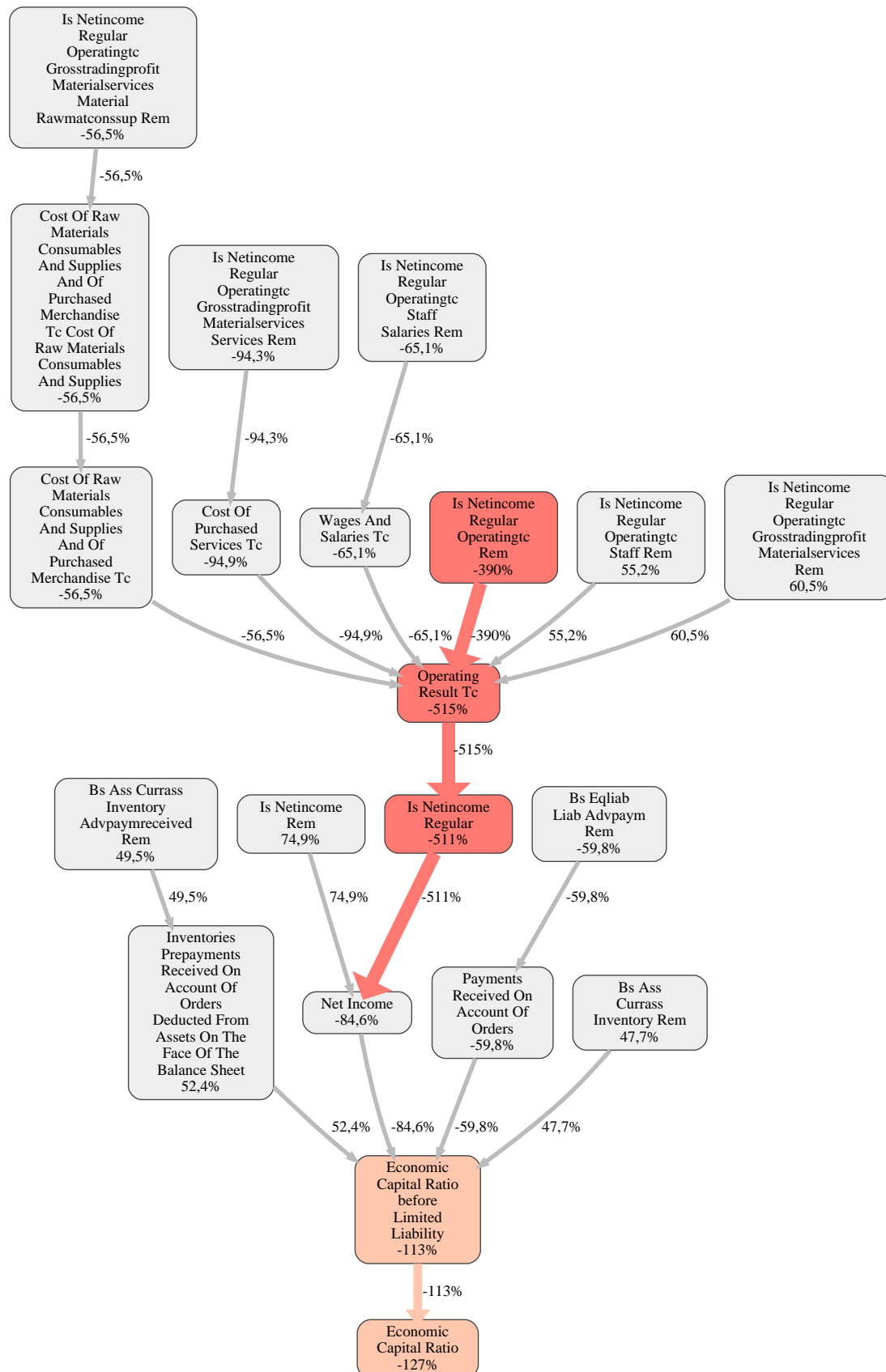

The greatest strength of Weberhaus GmbH Co KG compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 75% points. The greatest weakness of Weberhaus GmbH Co KG is the variable Operating Result Tc, reducing the Economic Capital Ratio by 515% points.

The company's Economic Capital Ratio, given in the ranking table, is 75%, being 127% points below the market average of 202%.
