

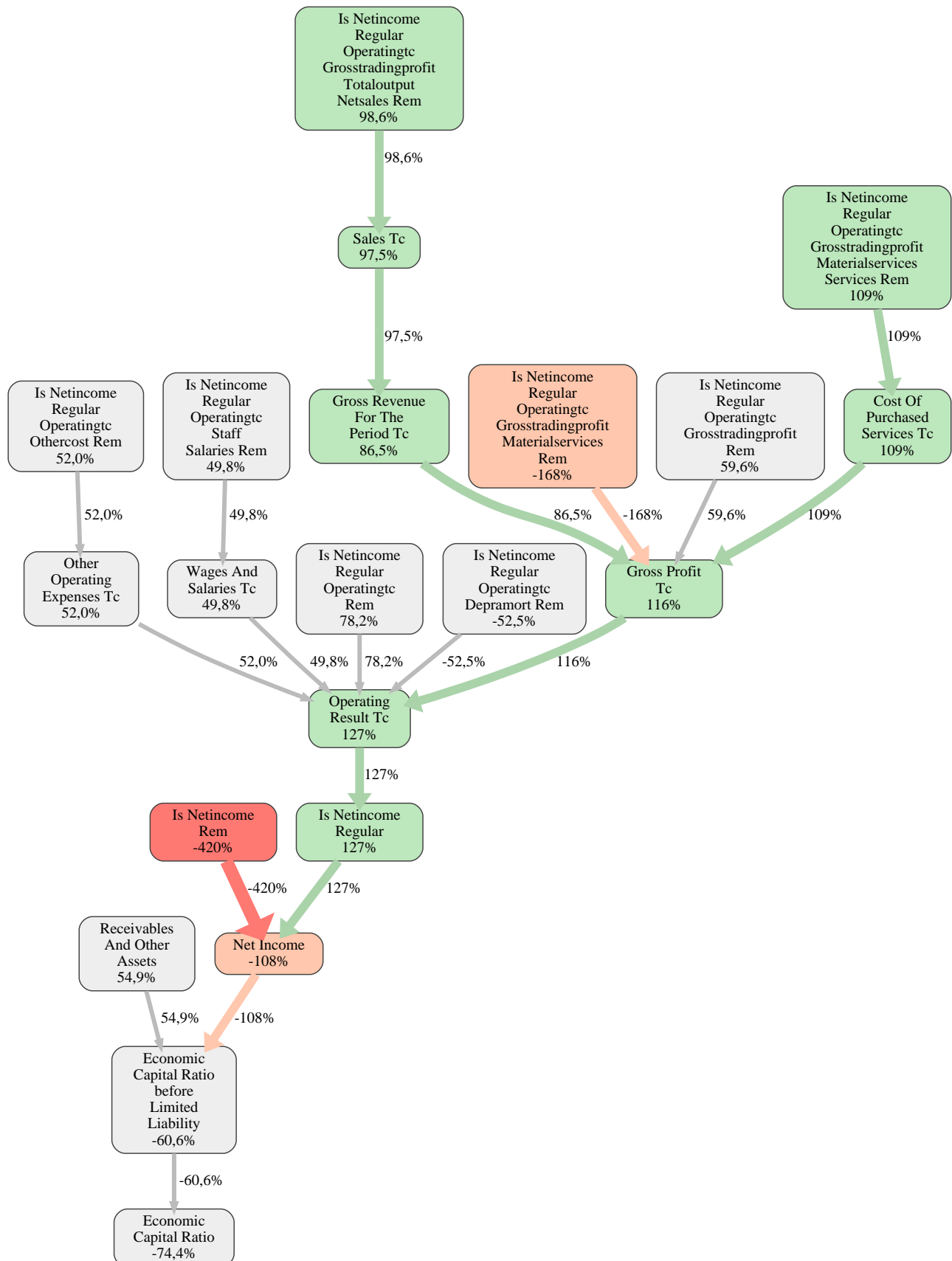

The relative strengths and weaknesses of THB Tief und Hausbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of THB Tief und Hausbau GmbH compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 127% points. The greatest weakness of THB Tief und Hausbau GmbH is the variable Is Netincome Rem, reducing the Economic Capital Ratio by 420% points.

The company's Economic Capital Ratio, given in the ranking table, is 127%, being 74% points below the market average of 202%.
