

The relative strengths and weaknesses of BAM Corporate Services GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BAM Corporate Services GmbH compared to the market average is the variable Is Netincome Rem, increasing the Economic Capital Ratio by 179% points. The greatest weakness of BAM Corporate Services GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 436% points.

The company's Economic Capital Ratio, given in the ranking table, is 210%, being 8,5% points above the market average of 202%.

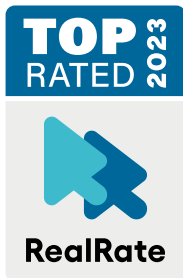
