The greatest strength of GP Con GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Rem, increasing the Economic Capital Ratio by 46% points. The greatest weakness of GP Con GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 164% points.

The company's Economic Capital Ratio, given in the ranking table, is 48%, being 153% points below the market average of 202%.
